# THE SWAZILAND ROYAL INSURANCE CORPORATION ORDER, 1973

(No. 32 of 1973)

# THE SWAZILAND ROYAL INSURANCE CORPORATION DIRECTOR'S FEES REGULATIONS, 1977

(Under Section 12)

(Commencement: 1st January, 1977)

In exercise of the powers conferred on hith by the abovementioned Order the Honourable Minister for Finance and Economic Planning is pleased to make the following regulations:

Citation.

 These regulations may be cited as the Swaziland Royal Insurance Corporation Director's Fees Regulations, 1977.

Payment of Fees to directors.

- 2. (1) With effect from the 1st January, 1977 a fee of E500 per annum shall be paid to a director of the Swaziland Royal Insurance Corporation appointed as such under sections 7(5) and 7(6) of the Swaziland Royal Insurance Corporation Order No. 32 of 1973.
- (2) If a director serves as such for less than a year he shall be paid at the rate of E40 for every month's service or part thereof.
- (3) Nothing in these regulations shall be construed to mean that any remuneration shall be paid to a public servant appointed as such to act as a Director.

### LEGAL NOTICE NO. 112 OF 1977

### THE IMMIGRATION ACT 1964

(No. 32 of 1964)

### THE IMMIGRATION (AMENDMENT) (NO. 2) REGULATIONS, 1977

(Under section 32)

(Commencement: 1st November, 1977)

In exercise of the powers conferred on him by the above-mentioned Act, the Honourable the Deputy Prime Minister is pleased to amend the First Schedule to the Immigration (Amendment) Regulations, 1977 with effect from the 1st of November, 1977 in the following respects —

(a) Item 3 is amended by adding the following proviso -

"Provided that in the case of a student attending university, college or school in Swaziland, the fee shall be E2";

(b) Items 6 and 7 are amended by adding the following proviso to each of them —

"Provided that in the case of a student attending university, college or school in Swaziland, the fee shall be E5."
