LEGAL NOTICE NO. 98 OF 1980

THE WEIGHTS AND MEASURES ORDER, 1975 (No. 27 of 1975)

THE WEIGHTS AND MEASURES (SALE OF BREAD) REGULATIONS, 1980. (Under section 43)

(Date of commencement: 26th December, 1980)

In exercise of the powers conferred on him by the above-mentioned Order the Minister for Commerce, Industry, Mines and Tourism is pleased to make the following regulations:

Citation.

 These regulations may be cited as the Weights and Measures (Sale of Bread) Regulations, 1980.

Interpretation.

- 2. In these regulations unless the context otherwise requires
 - "bread" means any baked wheaten or rye product which is sold as or under the name of bread but does not include fancy bread;
 - "fancy bread" means bread containing currents, raisins, cinnamon or other fruits and spices, and includes bread rolls, french rolls and twists, portuguese loaves, milk loaves, cake, confectionery, sandwiches, wholewheat bread and bread of the kind known as German rye bread;
 - "loaf" or "half-loaf" means a whole unit or prepacked sliced unit of bread, which, subject to the tolerances and the circumstances prescribed in regulations 4 and 5 hereof has a mass of 900g or 450g as the case may be.

Non-application of these Regulations.

3. These regulations shall not apply to fancy bread.

Prescribed units of mass and permissible tolerances.

4. Subject to Regulation 5 of these regulations no person shall make and sell any bread except in whole units of 900g and 450g:

Provided that -

- (a) the mass of any individual unit of bread may deviate from the standard mass prescribed herein, in deficiency or in excess to the extent set out in Table I of these regulations; and
- (b) the average mass of ten like units of bread selected at random from a batch derived from the same source shall not be less than 0,5% of the relative standard mass prescribed herein for a whole unit or a prepacked sliced unit.

Restrictions and Resale of Bread.

5. No person who purchases bread for resale shall sell such bread if, at the time of the resale, the mass of the bread is less than the standard mass prescribed in Regulation 3 to an extent greater than that set out in Table II of these regulations.

Prepacked Sliced Bread.

6. The sale or purchase of any prepacked sliced bread shall be deemed to be a sale or purchase of a whole unit of any applicable standard mass prescribed in Regulation 3 of these regulations.

Repeal.

7. Legal Notice No. 51 of 1977 is hereby repealed.
