LEGAL NOTICE NO. 132 OF 1982

THE DAIRY ACT, 1968

(Act No. 28 of 1968)

THE PRICES OF LIQUID MILK (NO. 2) REGULATIONS, 1982

(Under Section 24)

In exercise of the powers conferred upon him by Section 24 of the Dairy Act, 1968 the Minister for Agriculture and Co-operatives, after consultation with the Swaziland Dairy Board hereby makes the following Regulations —

Citation and commencement.

 These Regulations may be cited as the Prices of Liquid Milk (No. 2) Regulations, 1982 and shall come into force on the 2nd January, 1983.

Minimum price to be paid to a producer of milk.

2. The price to be paid by a milk processor to a milk producer for fresh milk delivered by him to such processor shall be not less than 25 cents a litre.

Maximum price to be paid to a milk processor by a milk purveyor.

- The price to be paid by a milk purveyor of liquid milk for fresh milk delivered to him by a processor shall be 54 cents per litre for packaged milk or 52 cents per litre of bulk milk.
- Maximum selling price of liquid fresh milk.
- 4. The maximum selling price of liquid fresh milk by dairies, milk shops and milk purveyors to the public shall be 58 cents per litre for cartoned milk.

Maximum price to be paid to a milk processor of cultured milk (Emasi) by a milk purveyor.

5. The price paid by a purveyor of cultured milk (Full Cream Emasi) delivered to him by a processor shall be 54 cents per litre for full cream cultured Emasi.

Maximum selling price of cultured milk (Emasi).

6. The maximum selling price of cultured milk (Emasi) by dairies, milk shops and milk purveyors to the public shall be 58 cents per litre for cartoned full cream milk; 52 cents per litre for bulk full cream milk.

Revocation of Legal Notice No. 60 of 1982.

7. The Prices of Liquid Milk Regulations, 1982 are hereby revoked.

LEGAL NOTICE NO. 133 OF 1982

THE ROAD TRANSPORTATION ACT, 1963

(Act No. 37 of 1963)

THE MAXIMUM BUS AND TAXI FARES (AMENDMENT) REGULATIONS, 1982

(Under section 28)

In exercise of the powers conferred by section 28 of the Road Transportation Act, 1963, the Minister for Works, Power and Communications, after consultation with the Road Transportation Board and the chairman of the Swazi Commercial Amadoda, hereby makes the following Regulations—

Citation.

1. These Regulations may be cited as the Maximum Bus and Taxi Fares (Amendment) Regulations, 1982, shall be read as one with the Maximum Bus and Taxi Fares Regulations, 1981 and shall come into force on the 31st January, 1983.

Amendment of regulation 2.

- 2. Regulation 2 of the Maximum Bus and Taxi Fares Regulations, 1981 is amended by replacing paragraph "(a)" with the following
 - "(a) buses operating within an urban area _____5 cents above the current fares."
