THE COMMISSIONS OF ENQUIRY ACT, 1963 (Act No. 35 of 1963)

THE COMMISSION OF ENQUIRY INTO THE GRIEVANCES OF VUVULANE IRRIGATED FARMS (SMALLHOLDERS) NOTICE, 1985

(Under section 3)

In exercise of the powers conferred by section 3 of the Commissions of Enquiry Act, 1963 I hereby issue the following Notice—

Citation.

1. This Notice may be cited as the Commission of Enquiry into the Grievances of Vuvulane Irrigated Farms (Smallholders) Notice, 1985.

Appointment of Commission.

- 2. (1) The Commission of Enquiry into the Grievances of Vuvulane Irrigated Farms Smallholders hereinafter called the "Commission" is hereby appointed.
 - (2) The Commission shall consist of the following Commissioners-

Functions of the Commission.

- 3. (1) The Commission shall enquire into and record the grievances of Vuvulane Irrigated Farms Smallholders relating to the agreements entered into between them and the Commonwealth Development Corporation and the Swaziland National Agricultural Development Corporation (Pty) Limited.
- (2) Without prejudice to the generality of paragraph (3), the Commission shall further
 - (a) examine and inquire into the terms and conditions of the agreements entered into between the Vuvulane Irrigated Farms Smallholders and the Commonwealth Development Corporation since inception up to the transfer of the Vuvulane Irrigated Farms Scheme to the King-in-trust for the Swazi Nation;
 - (b) examine and inquire into the terms and conditions of any agreement between the Vuvulane Irrigated Farms Smallholders and the Swaziland National Agricultural Development Corporation (Pty) Limited on the transfer of the Vuvulane Irrigation Scheme to the Swazi Nation;

- (c) to examine and inquire into any other related agreement relevant to the grievances of the Vuvulane Irrigated Farms Smallholders;
- (d) examine any other matter relating to the grievances of the Vuvulane Irrigated Farms Smallholders as the Commission may consider relevant to the foregoing; and
- (e) recommend appropriate action as a response to the Vuvulane Irrigation Smallholders' appeal to the Swaziland Government.

Enquiry venue.

4. The enquiry shall be held at the Swaziland National Archives at such times as the Chairman may determine.

Enquiry to be in camera.

5. Except where the Minister for Agriculture and Co-operatives otherwise directs, the enquiry shall be held in camera.

Quorum.

6. Five commissioners including the Chairman shall constitute a quorum for purposes of the enquiry.

Duration of enquiry.

7. The Commission shall commence its functions on the 1st July, 1985 and submit its report to the Minister for Agriculture and Co-operatives by the 1st September, 1985 or on such later date as the Minister for Agriculture and Co-operatives may permit in writing.
