LEGAL NOTICE NO. 120 OF 1985

THE CANE GROWERS ACT, 1967

(Act No. 12 of 1967)

THE IMPOSITION OF LEVY ON SUGAR CANE GROWERS NOTICE, 1985

(Under Section 4)

In exercise of the powers conferred by section 4 of the Cane Growers Act, 1967, the Minister for Agriculture and Co-operatives on the recommendations of the Swaziland Cane Growers' Association, hereby issues the following Notice—

Citation.

1. This Notice may be cited as the Imposition of Levy on Sugar Cane Growers Notice, 1985 and shall be deemed to have come into force on the 1st May, 1985.

Rate of levy.

- 2. The levy shall be at the rate of -
 - (a) E0.73 per metric ton supplied to, and accepted by, a miller from Vuvulane Irrigation Farms in possession of sucrose of 100 tonnes or less;
 - (b) E1.42 per metric ton supplied to, and accepted by, a miller from all other growers,

during the period from the 1st May, 1985 to the 30th April, 1986.

Due date of levy.

- 3. (1) The due date of the levy in respect of each delivery of sucrose during any mill-month shall be the tenth day after the last day of such mill-month.
- (2) In the absence of satisfactory proof to the contrary the miller shall be deemed to have accepted sucrose on the date of delivery of such sucrose to him.
- (3) For the purposes of this Notice, "mill-month" shall have the meaning assigned to it in the Schedule to the Sugar Act, 1967.

Method of payment of levy.

4. A miller shall deduct the amount of levy on each Sugar Cane Grower from the periodic payments made to each grower for sucrose supplied by him and shall remit the amount of such levy to the Swaziland Cane Growers' Association by the due date.

THE PRICES OF COLOURED MARGARINE NOTICE, 1985

Citation and Commencement.

1. This Notice may be cited as the Prices of Coloured Margarine Notice, 1985 and shall come into force on the 18th October, 1985.

Maximum Prices of Coloured Margarine.

2. A person shall not sell coloured margarine at prices above the following wholesale and retail prices.

All brands of Margarine in bricks	E41.50	E0.90
*	Wholesale prices of 50 tubs of 250g each	Retail prices of 250g tubs
All brands of Margarine in tubs	E46.50	E1.02
