THE CENTRAL BANK OF SWAZILAND ORDER, 1974 (K.O.I.C. No. 6 of 1974)

THE CHARACTERISTICS OF NOTES TO BE ISSUED BY THE CENTRAL BANK OF SWAZILAND

(Under section 24(3))

In exercise of the powers conferred by section 24(3) of the Central Bank of Swaziland Order, 1974, I hereby issue the following Notice—

Citation.

1. This Notice may be cited as "characteristics of notes to be issued by the Central Bank of Swaziland 1987."

Currency.

2. The notes to be issued by the Central Bank of Swaziland in terms of this General Notice shall be legal tender within Swaziland in terms of Central Bank of Swaziland Order, 1974. Notes and coins issued in accordance with the General Notice No. 7 of 1974 also continue to be legal tender in Swaziland.

Denomination, size Weights and Background colour of notes.

3. The notes shall consist of mould-made banknote paper with melamine incorporating a watermark, and a metal security thread and shall be of the following denominations, sizes, weights and background colours:

DENOMINATION	SIZE	WEIGHT	MAIN BACK- GROUND COLOUR
2 Emalangeni	60 x 132 mm	87 gr per square metre	Dark Brown
5 Emalangeni	63 x 138 mm	87 gr per square metre	Green
10 Emalangeni	66 x 144 mm	87 gr per square metre	Blue

Design and Inscription of Notes.

- 4. The notes will bear the following designs and inscriptions:
 - On the obverse side of the 2 (two) Emalangeni the 5 (five) Emalangeni and 10 (ten) Emalangeni notes shall be printed and inscribed.
 - (a) To the left of the centre the printed image of HIS Majesty King Mswati III.
 - (b) To the right of the centre in a white space a watermark representing a Swazi shield complete with two spears and a staff.
 - (c) At the top and central printed words "CENTRAL BANK OF SWAZI-LAND" and below, the words "THIS NOTE IS LEGAL TENDER FOR LAMABILI EMALANGENI" 2 (two); "LASIHLANU EMALANGENI" 5 (five) and "LALISHUMI EMALANGENI" 10 (ten) respectively.

- (d) In the centre of the note the image of the Parliament buildings.
- (e) At the bottom centre a medallion depicting the National Coat of Arms, printed in brown on the 2 (two) Emalangeni and 5 (five) Emalangeni and in black on the 10 (ten) Emalangeni, and partially covering the Parliament buildings. The National coat of arms consists of an image of a Swazi shield with two spears and a staff, an elephant with its trunk raised on the right of the shield a lion with its left fron paw raised on the left of the shield.

In the scroll beneath are the capital Roman letters "SIYINOABA."

- (f) On the bottom right hand side of the note a spear on the 2 (two) Emalangeni a staff with a scrolled top on the 5 (five) Emalangeni and a staff with feathers on the 10 (ten) Emalangeni.
- (g) On the left of the portrait the image of a Swazi shield with two spears and a staff with feathers printed in perfect register with a similar feature on the back of the design.
- (h) Just above the House of Parliament a reprint of signatures of the Minister for Finance on the central left; and the Governor of the Central Bank on the central right.
- On the top left, top right and bottom right corner the printed values 2 (two)
 (five) and 10 (ten) in Arabic numerals.
- (j) The serial numbers for the notes consisting of a Roman capital letter and six Arabic numerals printed below the portrait and also above the watermark.
- (k) A security metal thread embedded in the paper of the note to the left of centre.
- (1) A border and central panel of intricate geometrical designs.
- 2. On the reverse side of the 2 (two), 5 (five) and 10 (ten) Emalangeni notes.
 - (a) At the top, the words "Central Bank of" in small case Roman letters followed by the word "Swaziland" in upper case Roman letters.
 - (b) At the bottom the words "TWO EMALANGENI" on the 2 (two) "FIVE EMALANGENI" on the 5 (five) and "TEN EMALANGENI" on the 10 (ten) in upper case Roman letters.
 - (c) At the top left, bottom left and bottom right the Arabic numerals 2 (two), 5 (five) and 10 (ten) respectively.
 - (d) On the 2 (two) the central vignette is a design based on nature conservation showing a purple crested lourie bird, a giraffe, two hippopotami, three zebras, two, cranes and a butterfly against a background of the Mlilwane Mountains.
 - (e) On the 5 (five) the central vignette is an image of a Swazi regiment against a background of the Mdzimba Mountain.
 - (f) On the 10 (ten) the Central vignette is an image of the Luphohlo Hydro electric scheme.
 - (g) On the 2 (two) 5 (five) 10 (ten) to the right an image of a shield, with two spears and a staff in perfect register with an identical image on the front.
 - (h) A border of intricate geometrical designs similar to the front.

In exercise of the powers conferred by section 13 of the Cotton Act, 1967 the Minister for Agriculture and Co-operatives, after consulting the Cotton Board, hereby issues the following Notice—

Citation.

1. This Notice may be cited as the Cotton Levy Notice, 1987.

Interpretation.

2. In this Notice -

"Principal Act" means the Cotton Act, 1967.

Imposition of Levy 1986/87.

3. A levy of 0.5 of one cent per kilograms of seed cotton produced by a grower in respect of the 1986/87 season is imposed.

Date before which payment to be made.

4. The levy imposed by paragraph 3 shall be paid before 1st December, 1987.

Method of Payment.

- 5. The grower shall pay the levy under paragraph 3 and a surcharge of it under section 13(b) of the Principal Act at his option to
 - (a) the Executive Officer of the Cotton Board: or
 - (b) the following who have agreed with the Cotton Board to deduct the levy from the purchase price of seed cotton purchased and to pay the amount to the Executive Officer in accordance with section 13(7) of the Principal Act, namely —
 - (i) Swaziland Cotona Ginning Company (Pty) Limited.
 - (ii) J.C. Clark Cotton Company (Pty) Limited.
 - (iii) Swaziland Oil Seeds Mills (Pty) Limited
 - (iv) Swaziland Cotton Co-operative Society Limited.

Recovery of Levy.

 The Board may recover from a ginner an unpaid levy and surcharge under section 13 of the Principal Act.
