Citation.

1. This Notice may be cited as the Matsapha Township (Extension of Boundaries) Notice, 1987 and shall come into force on the 20th March, 1987.

Extension of Township and alteration of general plan.

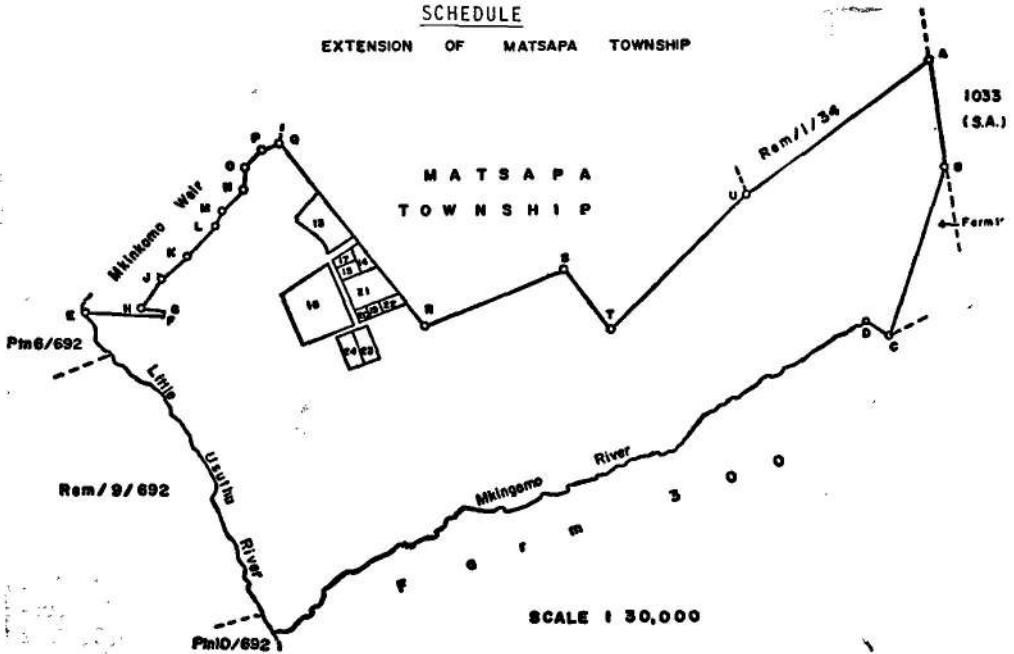
2. (a) The boundaries of Matsapha Township are extended to include portions 13,14, 15, 16, 17, 19, 20, 21, 22, 23, 24, of Farm No. 34 and the remaining extent of Farm No. 34 represented by the figure A, B, C, D Mid Mkingomo River confluence Mid Little Usuthu River E, F, G, H, J, K, L, M, N, O, P, Q, R, S, T, U, as set out in the Schedule hereto.
(b) The Surveyor-General shall alter the General Plan so as to include the extension of the boundary assigned in this Notice and endorse the General Plan SG. No. S. 39/66 accordingly.
3. The Registrar of Deeds shall —
 - (a) make the necessary endorsements on the relevant title deeds; and
 - (b) open the necessary register in connection with the Township.
