### THE WAGES ACT, 1964

(Act No. 16 of 1964)

# REGULATION OF WAGES (MANUFACTURING AND PROCESSING INDUSTRY) (AMENDMENT) ORDER, 1987

(Under section 11)

In exercise of the powers conferred on him by section 11 of the Wages Act, 1964 the Minister for Labour and Public Service hereby makes the following Order—

#### Citation and commencement.

1. This Order may be cited as the Regulation of Wages (Manufacturing and Processing Industry) (Amendment) Order, 1987 and shall come into force on 1st June, 1987.

### Amendment of paragraph 2.

2. Paragraph 2 of the Regulation of Wages (Manufacturing and Processing Industry) Order, 1987 is amended by deleting the word "hand craft".
