THE WAGES ACT, 1964 (Act No. 16 of 1964)

# THE REGULATION OF WAGES (MINING AND QUARRYING INDUSTRY) (AMENDMENT) ORDER, 2014 (Under Section 11)

In exercise of the powers conferred by Section 11 of the Wages Act, 1964, the Minister for Labour and Social Security hereby makes the following Order:-

#### Citation and Commencement

- 1. This Order may be cited as the Regulation of Wages (Mining and Quarrying Industry) (Amendment) Order, 2014 and shall be deemed to have come into force on the 1st October, 2014 Amendment of Regulation of Wages (Mining and Quarrying Industry) Order, 2014.
- 2. The Regulation of Wages (Mining and Quarrying Industry) Order issued under Legal Notice No. 55 of 2014 is amended as follows;
  - (a) By adding a Third Schedule to the Regulations as follows.

#### THIRD SCHEDULE

#### Minimum Ration Payable per Day

i. The minimum ration payable to each employee shall be E15.00; alternatively the daily rations may be supplied in items of food equivalent to this amount.

#### Minimum Housing Allowance per Month

- ii. The minimum housing allowance payable per month to each employee shall be E250.00; Alternatively the employer shall provide the employee with decent housing in the manner and with the amenities required by the Employment Regulations of 1981.
  - (b) In Regulation 15, by deleting the words "relevant regulation thereto" and replacing them with the words "Third Schedule"
  - (c) In Regulation 16(1) by adding after the word "suppli "and at the end of the sentence, the words "in terms of the Third Schedule hereto"
