#### Gaborone Broadhurst "A" Development Stage II Water Supply

The Project is financed by the European Economic Community/European Development Fund.

Suitably qualified contractors are invited to tender for one or both of the following contracts:

The contracts are expected to be let in the first 5 months of 1978.

The total amount of the works is estimated at approximately P 1,7 million, or M.U.A. 1,8 million.

#### Contract A 274/A/1 WATER MAINS

The Construction of approximately 400 m of 600 mm diameter: 1250 M of 375 mm diameter; 1150 m of 300 mm diam. asbestos cement trunk water main, and 40 km of distribution mains varying in diameter between 50 mm and 400 mm. Contract period 18 months.

#### Contract A 274A/2 RESERVOIRS AND ANCILLARY WORKS

The design and construction of two ground level treated water storage reservoirs of 4500 cubic metres capacity and one elevated treated water storage reservoir of 650 cubic metres capacity.

The construction of site pipelines and roads and the building content of one pumping station.

Contract period 15 months.

The works are located in Gaborone and in the suburb called Broadhurst.
