(No. 25 of 1973)

MAXIMUM WHOLESALE AND RETAIL PRICES OF BREAD IN SWAZILAND.

(Under Section 5(1))

(Date of Commencement: 13th January, 1978)

- 1. In exercise of the powers conferred upon me by the abovementioned Order, I hereby prescribe the maximum wholesale and retail selling prices of bread in Swaziland to be as set out in the schedule to this Notice.
- 2. In this Notice, the terms "bread" and "fancy bread" shall have the meanings assigned to them in the Weights and Measures (Sale of Bread) Regulations, 1977, (Legal Notice No. 51 of 1977).
