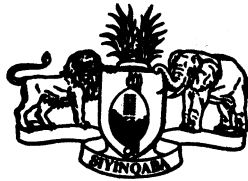

I ASSENT

SOBHUZA II

King of Swaziland

28th March 1978.

A KING'S ORDER-IN-COUNCIL

entitled

A King's Order-in-Council to provide for the appropriation of a certain sum of money.

*(Date of commencement: 1st April, 1978)*

ENACTED by the King in collaboration with the Council.

*Short title and commencement.*

1. This King's Order-in-Council may be cited as the Appropriation (1978/79) Order, 1978 and shall come into force on the first day of April, 1978.

*Charge to Consolidated Fund.*

2. The Consolidated Fund is charged with such sum of money not exceeding in the aggregate one hundred and twenty six million, eighty seven thousand emalangeni (E126,087,000) as is required for the services of Swaziland during the year ending the thirty first day of March, 1979.

*Application of Sum Appropriated (Schedule).*

3. The sum appropriated by section 2 shall be applied to the services set out in the first column of the Schedule and in the respective amounts appearing in the second column of the Schedule.
