(King's Order-in-Council No. 7 of 1978)

# A KING'S ORDER-IN-COUNCIL

# entitled

A King's Order in Council to amend certain sections of the Companies Act, No. 7 of 1912, namely Sections 10, 26, 61 and 62.

(Date of commencement: 1st January, 1978)

ENACTED by the King in collaboration with the Council.

Short title and commencement.

1. This King's Order-in-Council may be cited as The Companies Act (Amendment) Order, 1978 and shall be deemed to have come into force on the first day of January, 1978.

# Interpretation.

2. In this Order any section or subsection referred to is a section or subsection (as the case may be) of the Companies Act No. 7 of 1912.

Amendment of Section 10.

- 3. Section 10 is amended by the insertion immediately after subsection (7) thereof of the following new subsection:—
  - "(8) The registrar may on written application to him and on payment of the Prescribed fee reserve a name pending registration of a company or a change of name by an existing company:

Provided that such reservation shall be for a period not exceeding thirty days or such extended period, not exceeding in all sixty days as the registrar may in his discretion allow.

Replacement of section 26 by a new section.

- 4. Section 26 is replaced by the following —
- (1) Every company, including a foreign company, having a share capital shall during the month of June of every year make a list of all persons who are members of the company and all persons who, holding shares not fully paid up, ceased to be members since the date of the last return, or in the case of the first return, of the incorporation of the company.
- (2) The list shall, except in the case of a public company, state the names and addresses of all past and present members therein mentioned, and the number of shares held by each of the existing members at the date of the return, specifying shares transferred since the date of the last return, or, in the case of a first return, of the incorporation of the company, by persons who are still members and who have ceased to be members respectively and the dates of the registration of the transfers.
- (3) The list shall state the situation of the registered office of the company, the date of the last annual general meeting, the date of incorporation and registered number and shall contain a summary distinguishing between shares issued for cash and shares issued as fully or partly paid up otherwise than in cash, specifying the following particulars:
  - (a) the amount of the share capital of the company and number of the shares into which it is divided:
  - (b) the number of shares taken from the commencement of the company up to the date of return;
  - (c) the amount called up on each share;
  - (d) the total amount of calls received:
  - (e) the total amount of calls unpaid;
  - (f) the total amount of the sums (if any) paid by way of commission in respect of any shares or debanture, since the date of the last return;
  - (g) the total number of shares forfeited:
  - (h) the total number of shares or stock for which shares warrants are outstanding at the date of return;
  - (i) the total amount of share warrants issued and surrendered respectively since the date of the last return;
  - the number of shares or amount of stock comprised in each share warrants;
  - (k) the names and addresses of the persons who at the date of the return are the directors, managers, secretary and auditor of the company; and
  - the total amount of debt due from the company in respect of all mortgates and charges.
- (4) Save in the case of a private company the summary referred to in subsection (3) shall include a statement in the form of a balance sheet, audited by the company's auditors, containing summary of its share capital, its liabilities and its assets, giving such particulars as will disclose the general nature of such liabilities and assets, and how the values of those fixed assets have been arrived at:

Provided that such balance sheet need not include statement of profit and loss.

- (5) The list and summay shall be contained in a separate part of the register of members and the company shall at the same time as it makes application for its annual company licence, but not later than 31 July of each year, and in the form prescribed by the Minister transmit to the Registrar a copy signed by, or on behalf of, a director, manager or secretary of the company.
- (6) If a company fails to comply with any requirements of this section it shall be guilty of an offence and liable on conviction to a fine of ten emalangeni for every day that its default continues, and every director, secretary or other officer of the company who knowingly and wilfully authorises or permits such default shall be guilty of an offence and liable on conviction to a like penalty.

Replacement of Section 61 by a new subsection.

- 5. Section 61 is replaced by the following
  - "61 (1) Every company, at such times are in this section prescribed, shall hold general meetings to be known and described in the notices calling such meetings as annual general meetings of such company.
    - (2) Such meetings shall be held
      - (a) in the case of the first such meeting, within a period of eighteen months after the date of the incorporation of the company concerned;
      - (b) thereafter within not more than six months after the end of every ensuing financial year of such company; and
      - (c) within not more than fifteen months after the date of the last preceding such meeting of that company.
    - (3) The annual general meeting of a company shall deal with and dispose of the matters prescribed by this Order and may deal with and dispose of such further matters as are provided for in the articles of the company and, subject to this Order, any matters capable of being dealt with by any general meeting of the company.
    - (4) The registrar may, on application to him before the expiry of the period within which an annual general meeting of a company must be held and on good cause shown, and on payment of the prescribed fee, extend such period by a period not exceeding six months but, notwithstanding any such extension, the date for the holding of the first annual general meeting following the meeting in respect of which the extension is granted, shall be determined as if such meeting had been held on the last day on which it should have been held if the extension had not been granted.
    - (5) If for any reason an annual general meeting of a company is not or cannot be held as provided in this section or any matter required by this Order to be dealt with and disposed of at such meeting is not dealt with thereat, the registrar may, on application by the company or any member of its or his legal representative and on payment of the prescribed fee, call or direct the calling of a general meeting of the company which shall be deemed to be an annual general meeting, and may give such ancillary or conse-

quential directions as he may think expedient, including directions modifying or supplementing, in relation to the calling, holding and conduct of the meeting, the operation of the company's articles, and directions providing for one member or the legal representative of a member or any specified number of members present in person or by proxy, to be deemed to constitute a meeting, and any meeting called, held and conducted in accordance with any such direction shall for all purposes be deemed to be an annual general meeting of the company duly called, held and conducted.

- (6) For the purpose of determining the date for the holding of the next succeeding annual general meeting of a company after a meeting held in pursuance of subsection (5) of this subsection the provisions of subsection (4) shall mutatis mutandis apply.
- (7) Any company which fails to comply with any provision of subsections (1) and (2) or with any direction given by the registrar under subsection (5), and every director or officer of the company who knowingly is a party to the failure, shall be guilty of an offence.
- (8) A company which has failed to hold its annual general meeting within the time or extended time prescribed by subsections (1) and (4), or as directed by the Registrar under subsection (5), shall further be liable to pay to the Registrar additional fees of one rand for every day during which the default continues but not exceeding a maximum of twenty rand, and the decisions of the Registrar as to the number of days during which the company is in default shall be final."

Amendment of Section 62.

# A KING'S ORDER-IN-COUNCIL

## entitled

A King's Order-in-Council to amend section 6 of the General Administration Act No. 11 of 1905 and Sections 4, 6 and 71 of the Magistrate's Court Act No. 66 of 1938.

(Date of commencement: 26th May, 1978)

ENACTED by the King in collaboration with the Council.

Short title.

1. This King's Order-in-Council may be cited as The General Administration and Magistrates Court (Amendment) Order, 1978.

Amendment of Section 6 of the General Administration Act No. 11 of 1905.

2. Section 6 of the abovenamed Act is replaced by the following —

"The area within which a magistrate's court shall have and exercise jurisdiction shall be as set out in Government Notice No. 121 of 1963, or as hereafter defined by the Minister for Justice or as amended by him from time to time by Notice in the Gazette:—

Provided that -

(a) a magistrate's court sitting within any such area at which a magistrate other than the Principal Magistrate of Swaziland presides shall have and exercise jurisdiction throughout such area; and

(b) a magistrate's court presided over by the Principal Magistrate of Swaziland shall have and exercise jurisdiction throughout Swaziland irrespective of where such Court is sitting".

'Amendment of Seciton 4 of the Magistrate's Court Act. No. 66 of 1938.

3. Section 4 of the abovenamed Act is amended by inserting the following immediately after the words "subsection 4" thereof —

", subsection (4 bis)"

Amendment of Section 6 of the Magistrate's Court Act No. 66 of 1938.

4. Section 6 of the abovenamed Act is amended by replacing subsection (2) thereof by the following —

"Every process issued out of any Magistrate's Court shall be of force throughout Swaziland and may be served or executed in any district by the Messenger, or his duly appointed deputy, of the Court of such district".

Amendment of Section 71 of the Magistrate's Court Act No. 66 of 1938

5. Section 71 of the abovenamed Act is amended by replacing the words "the Court of that district" in subsection (1) thereof by the words —

"a Court sitting in such district".
