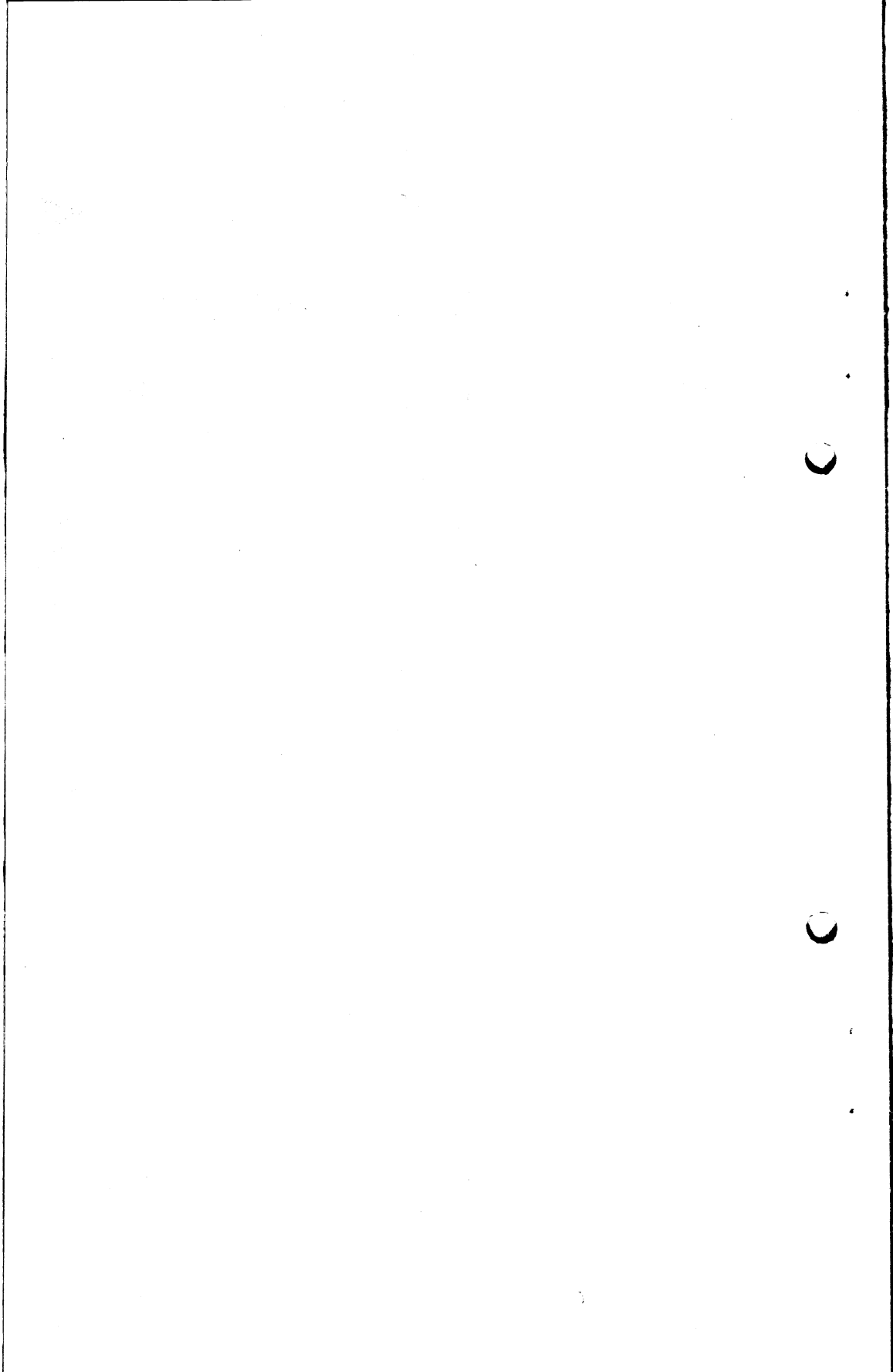

*(Date of commencement : 5th November, 1979)*

In exercise of the powers conferred on me by the abovementioned regulations, I hereby make the following order:

*Commencement*

1. This Order shall come into operation on the 5th November, 1979.
2. All owners of cattle in Swaziland shall dip their cattle once every seven days, that is, at intervals of six days between two dippings not including the two dipping days.
3. The dipping ordered under paragraph two above shall take place between the hours of sunrise and twelve noon.
4. General Notice No. 47 of 1979 published in Vol. XVII of the Government Gazette No. 948 dated 18th May, 1979 is hereby cancelled.

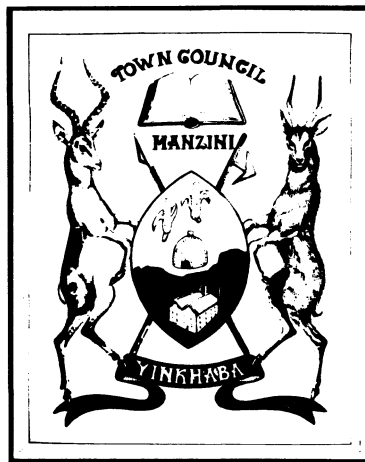
*Notification of Coat of Arms*

1. The Coat of Arms of Manzini Town Council



2. Description of the Coat of Arms

- a) A book, which signifies Manzini as the centre of learning;
- b) the shield, spear and "sizeze" are Swazi arms of war;
- c) the maize cobs represent maize stored in Manzini;
- d) the hut depicts the traditional Swazi dwelling house;
- e) the structure below the hut represents the industrial activities to be found in and around Manzini;
- f) the bucks — one on the left is an impala and the other is an "imbhabala" — represent the wildlife found around Manzini; and
- g) the inscription "YINKABA" means the central part and, in the context of the coat of arms, signifies Manzini Town as the hub of Swaziland.
