### THE ROYAL EMOLUMENTS, CIVIL LIST AND OTHER REMUNERATIONS BILL, 1983.

(Bill No. 3 of 1983)

#### MEMORANDUM IN TERMS OF THE STANDING ORDERS OF PARLIAMENT

The purpose of this Bill is to prescribe, as required by law, the emoluments and civil list of the King, the remuneration of the Ndlovukazi (acting as Regent) and of the Authorised Person.

This Bill also seeks to repeal the Royal Emoluments and Civil List Act, 1968.

#### A BILL entitled

An Act to prescribe the emoluments and civil list of the King and the remuneration of the Ndlovukazi (acting as Regent) and of the Authorised Person and to provide for other matters incidental thereto.

#### *Short title and commencement.*

1. (1) This Act may be cited as the Royal Emoluments, Civil List and other Remunerations Act 1983 and, except as otherwise provided in subsection (2), shall come into operation on the 1st April, 1983.

(2) The provisions of this Act relating to the remuneration to the Regent and the Authorised Person shall be deemed to have come into operation on the 25th August, 1982.

#### *King's Emoluments, Civil List and remuneration of Regent and Authorised Person.*

2. The King's emoluments and civil list and the remuneration of the Regent and Authorised Person shall be as set out in the Schedule.

#### *Repeal of Act No. 11 of 1968.*

3. The Royal Emoluments and Civil List Act, 1968 is hereby repealed.
