LEGAL NOTICE NO. 22 OF 1983

THE AVIATION ACT 1968

(Act No. 31 of 1968)

THE AVIATION (AMENDMENT) REGULATIONS, 1983

(Under section 21)

In exercise of the powers conferred upon him by section 21 of the Aviation Act 1968, the Minister for Works Power and Communications hereby makes the following Regulations;

### *Citation.*

1. These Regulations may be cited as the Aviation (Amendment) Regulations shall be read as one with the Aviation Regulations, 1969 (hereinafter referred to as "the principal Regulations") and shall come into force on the 8th April, 1983.

### *Amendment of Regulation 176.*

2. Regulation 176 of the principal Regulations is amended by adding after sub-regulation (5) the following—

(6) No building, structure or other obstruction, including trees, shall, without the prior approval of the Director, be erected or permitted to exist within 2000 feet (600m) from any site housing radio or electronic apparatus used as aids to safety in our navigation.

(7) Where the obstructions referred to in sub-regulation (6) are less than 2000 feet (600m) from the site, such obstructions should not subtend a vertical angle greater than 1.2° (degrees) from the horizontal plane of the antenna of the apparatus.
