THE KING'S PROCLAMATION TO THE NATION OF 1973 THE KING'S PROCLAMATION (AMENDMENT) DECREE, 1983

In exercise of the powers vested in me, I, SOZISA, AUTHORISED PERSON OF THE KINGDOM OF SWAZILAND hereby make the following Decree:

Short Title

1. This Decree may be cited as the King's Proclamation (Amendment) Decree, 1983 and shall be read and construed as one with the King's Proclamation to the Nation of April 12th, 1973, and shall come into force with immediate effect.

Amendment of Proclamation

2. The King's Proclamation to the Nation of 1973 is amended by adding the following paragraph:

"15. (1) It is hereby re-affirmed and decreed that, according to Swazi Law and Custom, no matters which by virtue of paragraph 6 of the King's Proclamation No. 1 of 1981 – read together with schedule 3 of the repealed Constitution which schedule is hereby re-affirmed – continue to be regulated by Swazi Law and custom shall be enquired into or pronounced upon by any court of the Kingdom of Swaziland; whether or not such matters are pending before any such court on the date of coming into operation of this Decree.

"2 More particularly, but without in any manner whatsoever limiting the generality of the aforegoing sub-paragraph, no such court shall have any power to adjudicate on the irregularity or otherwise of the appointment of the Indlovukazi and/or the Authorised Person or on the validity or otherwise of this Regent's Decree; and no suits, applications, actions or other processes, whatever, shall be heard or adjudicated upon by any such court.

"(3) Any judgement, order, decree or finding whatsoever pronounced by any such court on any of the aforesaid matters, whether or not any such matters are pending or not before any such court, shall be null and void in law.

"(4) In as far as there maybe any conflict or difference between this decree and the said King's Proclamation to the Nation or any amendment thereof, the provisions of this decree shall prevail."

(1) It is hereby re-affirmed and decreed that, according to Swari Law and Custom, no matters which by virtue of paragraph 6 of the King Proclamation No. 1 of 1981 – read together with schedule 3 of the repeated Constitution which schedule is hereby re-affirmed - continue to be regulated by Swari Law and custom shall be enquired into or pronounced upon by any court of the Kingdom of Swariland; whether or not such matters are pending before any such court on the date of coming into operation of this Decree.

"2 More particularly, but without in any manner whatsoever limiting the generality of the aforegoing sub-paragraph, no such court shall have any power to adjudicate on the irregularity or otherwise of the appointment of the Indiovakai and/or the Authoriaed Person or on the validity or otherwise of this Regent's Decree; and no suits, applications. actions or other processes, whatever, shall be heard or adjudicated upon by any such court.

"(3) Any judgement, order, decree or finding whatsoever pronounced by any such court on any of the aforesaid matters, whether or not any such matters are pending or not before any such court, shall be null and void in law.

"(4) In as far as there maybe any conflict or difference between this decree and the said King's Proclamation to the Nation or any smendment thereof, the provisions of this decree shall prevail."
