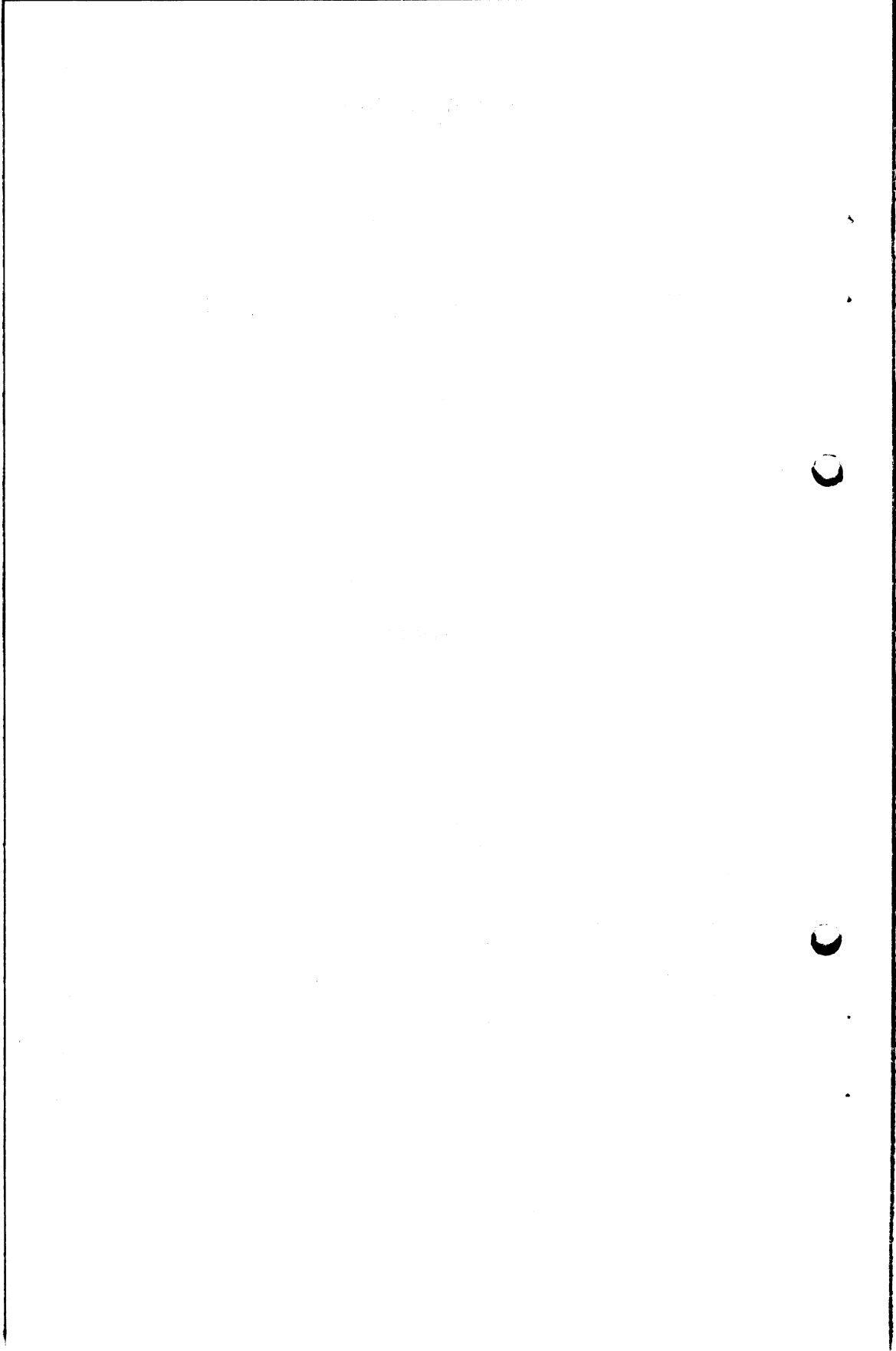

THE DIPPING OF STOCK NOTICE, 1984

(Under regulation 11)

In exercise of the powers conferred upon me by Regulation 11 of the Stock Diseases Regulations, 1933, I hereby issue the following Notice:-

Citation and commencement.

1. This Notice may be cited as the Dipping of Stock Notice, 1984 and shall come into force on the 28th May, 1984.

Compulsory dipping of stock.

2. (i) Subject to paragraph (ii) all owners of cattle in Swaziland shall dip their cattle once every fourteen days.
- (ii) Owners of cattle in the Schedule hereto shall dip their cattle once every twenty eight (28) days.

Dipping hours.

3. Subject to any directions to the contrary issued by an officer authorised under Regulation 11, dipping hours under Regulation 2 of this Notice shall be between 7.00 a.m. and 12.00 noon.

Revocation of Legal Notice No. 125 of 1983.

4. The Dipping of Stock Order, 1983 is hereby revoked.

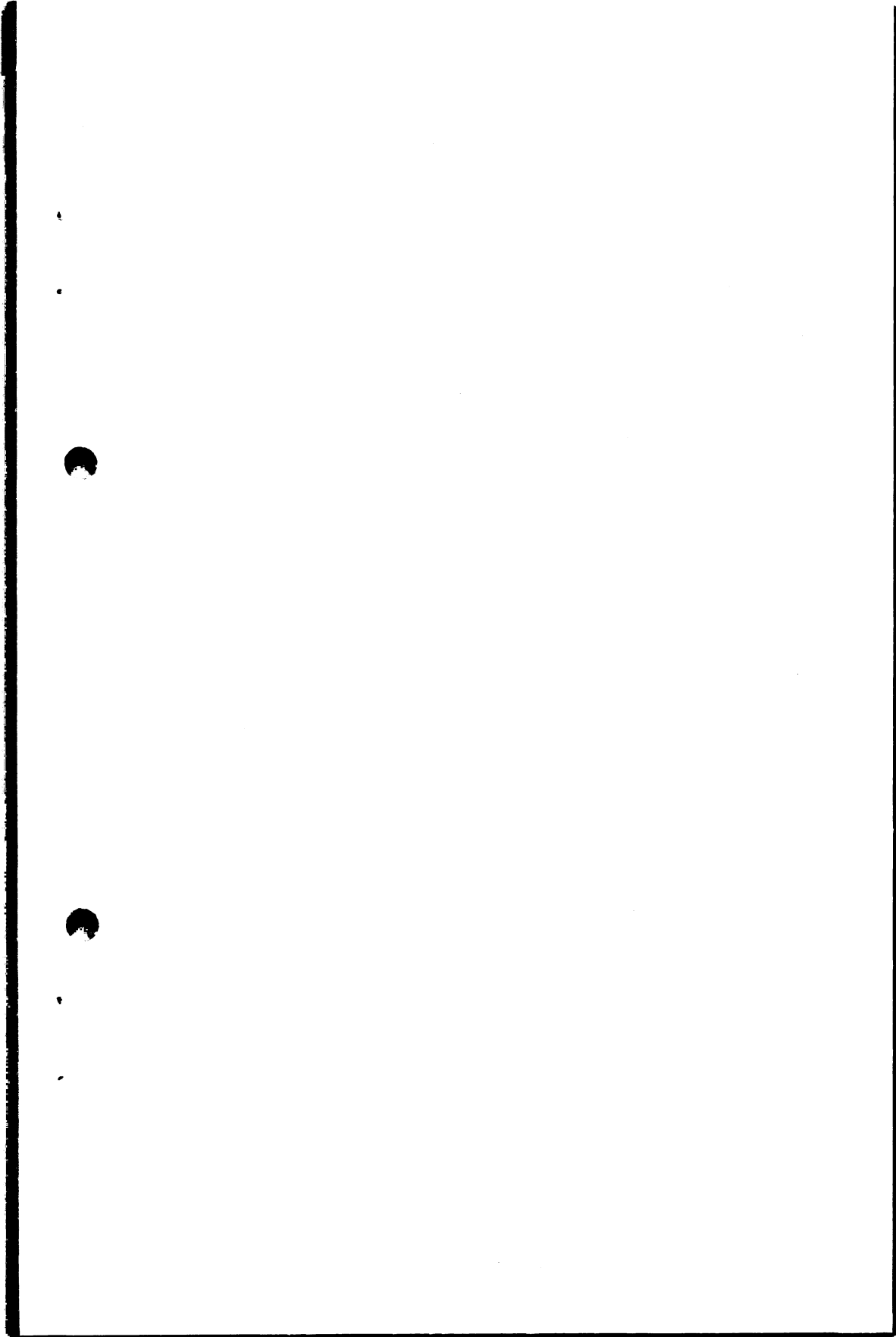
