## THE EMPLOYMENT ACT, 1980

#### (Act No. 5 of 1980)

#### THE MINIMUM CASH PAYMENT IN LIEU OF RATIONS NOTICE, 1985

#### (Under Section 153)

In exercise of the powers conferred by section 153 of the Employment Act, 1980 the Minister for Labour and Public Service hereby issues the following Notice-

#### Citation.

1. This Notice may be cited as the Minimum Cash Payment in Lieu of Rations Notice, 1985 and shall come into force on the 1st March, 1985.

#### Minimum cash payment in lieu of rations.

2. Where an employer is required under section 153 of the Employment Act, 1980 to supply rations to his employees, and is authorised to pay cash in lieu of such rations, the employer shall pay not less than E11.00 (eleven Emalangeni) per week to each employee.

#### Revocation of Legal Notice No. 88 of 1982 and No. 6 of 1985.

3. The Minimum Cash Payment in Lieu of Rations Notice, 1982 and the Minimum Cash Payment in Lieu of Rations Notice, 1985 are hereby revoked.
