LEGAL NOTICE NO. 74 OF 1985

THE SALES TAX ACT, 1983

(Act No. 12 of 1983)

THE SALES TAX (AMENDMENT OF SCHEDULES) ORDER, 1985

(Under section 9)

In exercise of the powers conferred upon him by section 9 of the Sales Tax Act, 1983, the Minister for Finance hereby makes the following Order:-

Citation.

1. This Order may be cited as the Sales Tax (Amendment of Schedules) Order, 1985 and shall come into force on 28 June, 1985 and shall be read as one with the Sales Tax Act, 1983 (hereinafter referred to as "the Act").

Amendment of Second Schedule.

2. Division II of the Second Schedule to the Act is amended —

(a) by inserting after item 1.06 the following—

“1.07 Goods imported —

- (a) for the relief of distress of persons in cases of famine or other national disaster declared as such by the Minister;
- (b) under any technical assistance agreement; or
- (c) in terms of an obligation under any multilateral agreement to which Swaziland is a party.

1.08 Goods imported unsolicited and free by any organization of a public character approved by the Minister which carries on charitable activities, subject to the production at the time of importation of a written declaration by such organization that the goods have been imported for the sole use of such organization or for free distribution by such organization in the furtherance of its charitable activities”.

(b) by replacing item 2.01 with the following —

“2.01 Goods, other than goods imported by any enterprise specified in item 1.05 of the Third Schedule, intended to be so used in manufacture that such goods or some element thereof will form an integral part of other goods to be manufactured in Swaziland and will remain in the goods so manufactured as an element or essential thereof in their completely manufactured condition.”.

Amendment of Third Schedule.

3. The Third Schedule to the Act is amended by inserting after item 1.06 the following—

“1.07 Goods purchased —

S2

- (a) under any technical assistance agreement between the Government to Swaziland and any other Government or international organization;
- (b) in terms of an obligation under any multilateral agreement to which Swaziland is a party.

1.08 Goods purchased prior to payment of sales tax by any organization of a public character approved by the Minister which carries on charitable activities, subject to the production at the time of purchase of a written declaration by such organization that the goods will be distributed free of charge by such organization in the furtherance of its charitable activities.”.

THE MAXIMUM WHOLESALE AND RETAIL SELLING PRICES OF

SOFT DRINKS (AMENDMENT) (NO. 2) NOTICE, 1985

(Under section 5)

In exercise of the powers conferred by section 5 of the Price Control Order, 1973, I hereby issue the following Notice —

Citation and commencement.

1. This Notice may be cited as the Maximum Wholesale and Retail Selling Prices of Soft Drinks (Amendment) (No. 2) Notice, 1985 shall be read as one with the Maximum Wholesale and Retail Selling Prices of Soft Drinks Notice, 1985 and shall come into force on the 28th June, 1985.

Amendment of Legal Notice No. 19 of 1985.

2. The Maximum Wholesale and Retail Prices of Soft Drinks Notice, 1985 is amended in the Schedule by replacing the prices of soft drinks other than appletizer with the following—

LEGAL NOTICE NO. 69 OF 1985

THE DAIRY ACT, 1968

(Act No. 28 of 1968)

THE PRICES OF BUTTER AND CHEESE NOTICE, 1985

(Under section 24)

In exercise of the powers conferred by section 24 of the Dairy Act, 1968 the Minister for Agriculture and Co-operatives after consulting the Swaziland Dairy Board hereby makes the following Notice —

Citation and Commencement.

1. These Regulations may be cited as the Prices of Butter and Cheese Regulations, and shall come into force on the 21st June, 1985.

Maximum selling prices of Butter.

2. (1) The maximum selling price of Grade 1 butter by a producer, processor, manufacturer or importer of butter to a restaurant, hotel, milk shop, dairy or milk purveyor shall be E5.36 per kilogramme.

(2) The maximum selling price of Grade 1 butter to a consumer shall be E5.80 per kilogramme.

Maximum selling price of Cheese.

3. (1) The maximum selling price of Grade 1 cheese by a producer, processor, manufacturer or importer of cheese to a restaurant, hotel, milk shop, dairy or milk purveyor shall be E5.50 per kilogramme for cheddar cheese and E5.55 per kilogramme for gouda cheese.

(2) The maximum selling price of Grade 1 cheese to a consumer shall be E5.90 per kilogramme for cheddar cheese and E5.97 per kilogramme for gouda cheese.

Revocation of Legal Notice No. 117 of 1984.

The Prices of Butter and Cheese Regulations, 1984 are hereby revoked.
