REMOVAL OF ADVERTISING SIGNS ALONG PROCLAIMED ROADS

(Under section 60)

Notice is hereby given that all advertising signs erected within the limits of any public road are to be removed by the owners within 30 days of the publication of this Notice unless it can be shown that prior approval to display such signs had been granted.

The owners of such signs who wish to continue to display must apply or reapply for permission to do so to "The Senior Roads Engineer, Ministry of Works & Communications P.O. Box 58, Mbabane" within the said 30 days failing which The Ministry of Works & Communications shall arrange for their removal under the powers delegated by the Minister under Section 60 of the above Act.

THE CROWN LANDS DISPOSAL ACT, 1911

(Act No. 13 of 1911)

THE MATHENDELE TOWNSHIP (EXTENSION NO. 5) REGULATIONS, 1986

(Under section 12)

The Minister for Natural Resources and Energy hereby makes the following Regulations:-

Citation.

1. These Regulations may be cited as the Mathendele Township (Extension No. 5) Regulations, 1986 and shall come into force on the 14th March, 1986.

Establishment of Township and alteration of General Plan.

- 2. (a) The following land is hereby proclaimed and established as a township:-
 - Farm No. 1258 situate in the Shiselweni District in extent 10,7903 (ten comma seven nine nought three) hectares held by the CROWN under Certificate of Registered Title No. 150 of 1980 dated the 20th day of June, 1980, comprising 110 (one hundred and ten) lots numbered 291 to 400 and roads as will more fully appear from General Plan S.G. No. S. 138/79 approved by the Surveyor General on the 24th day of September, 1979.
 - (b) The Surveyor General shall alter the General Plan so as to indicate the name and lot numbers assigned by these regulations to the township and endorse the General Plan S.G. No. S. 138/79 accordingly.
- 3. The Registrar of Deeds shall:-
 - (a) make the necessary endorsement on the relevant title deeds; and
 - (b) open the necessary register in connection with the Township.
