# THE SALES TAX (AMENDMENT OF SCHEDULES) (NO. 2) ORDER, 1986

#### (Under section 9)

In exercise of the powers conferred by section 9 of the Sales Tax Act, 1983, the Minister for Finance hereby makes the following Order-

Citation and commencement.
