# REPORT OF THE DIRECTORS FOR THE YEAR ENDED 31ST DECEMBER, 1985

The directors have pleasure in submitting their report together with audited annual financial statements for the year ended 31st December, 1985.

#### STATE OF AFFAIRS

The state of affairs of the Bank are fully set out in the annual financial statements for the year ended 31st December, 1985.

#### 2. SHARE CAPITAL

The authorised and issued share capital of the company at 31st December, 1985 is E1 387 000 divided into 13 870 shares of E100 each.

In terms of Section 18(1)(a)(i) of the Financial Institutions (Consolidation) Order, 1975, the Bank is required to maintain unimpaired share capital of at least 5% of its liabilities to the public in terms of the most recent published balance sheet. As at 31st December, 1985 the Bank's liabilities to the public totalled E28.34 million and accordingly authority will be sought at an extraordinary meeting to increase the authorised and issued share capital to E1 417 000 by means of a bonus issue of 300 shares of E100 each out of retained earnings.

#### 3. DIVIDENDS

It is recommended by the Board of Directors that no dividend be declared.

#### 4. TRANSFER TO STATUTORY RESERVES

In terms of Section 18(1)(a)(ii) of the Financial Institutions (Consolidation) Order, 1975 the Bank is required to transfer not less than 25% of its net profit to a statutory reserve account and accordingly E33 489 has been transferred to this account.

#### 5. DIRECTORATE

Mr. I.A. Rizvi and Mr. A. Shaik resigned as directors during the year and Mr. H.B. Nadkarni was appointed a director in the year. There were no other changes in the year.

#### 6. DIRECTORS' REMUNERATION

The fees paid to directors for the year amounted to E12 600, which are subject to approval by the shareholders.

#### 7. AUDITORS

At the Annual General Meeting you will be asked to determine the remuneration of the Auditors, Messrs. Peat, Marwick, Mitchell & Co. in respect of the past audit and to re-appoint them in office until the conclusion of the next Annual General Meeting.

# NOTES TO THE ANNUAL FINANCIAL STATEMENTS AT 31ST DECEMBER, 1985

#### 1. ACCOUNTING POLICIES

The principal accounting policies adopted are as follows:-

#### 1.1 Bad and doubtful debts

Advances are stated after deduction of amounts required as general and specific loan loss reserves against doubtful debts and after deducting interest on advances which is not taken to revenue because recovery is doubtful.

#### 1.2 Depreciation

Leasehold improvements have been amortised so as to write off the cost over the period of the lease.

Equipment and furniture are depreciated on a straight line basis at rates considered appropriate to write off the assets over their anticipated economic lives.

### 1.3 Assets under lease

Leasing contracts are regarded as financing transactions and the total rental instalments receivable thereunder, less unearned finance charges, are included in advances and other accounts in the balance sheet.

#### 1.4 Foreign currencies

Assets and liabilities in foreign currencies have been converted at the approximate rates of exchange ruling at the financial year end.

#### 1.5 Deferred taxation

Deferred taxation is provided in respect of timing differences resulting from the accounting and taxation treatment of leasing income and depreciation of fixed assets except where such timing differences result in a deferred asset.

#### 1.6 Income recognition

Commission charged to customers on letters of credit and letters of guarantees and interest on discounting bills are credited to income at the time of effecting the transactions.

The interest portion of lease rental instalments is taken to revenue over the period of the lease in proportion to the capital balance outstanding; other charges relating to leasing contracts are credited to income as received.

## CONTROL OF PRICES OF MAIZE AND MAIZE MEAL NOTICE, 1986

(Under Section 4)

In exercise of the powers conferred by section 4 of the Control of Cereals Act, 1959 the Minister for Agriculture and Co-operatives hereby issues the following Notice—

#### Citation and commencement.

1. This notice may be cited as the Control of Prices of Maize Meal Notice, 1986 and shall come into force on the 13th of June, 1986.

### Interpretation.

#### 2. In this Notice—

- "bag of maize" means a unit of 70 Kgs net weight of maize fit for human consumption and packed in a sound container;
- "bag of maize meal" means a unit of 80Kgs net weight of maize meal fit for human consumption and packed in a sound container;
- "buyer" means a person who holds a licence to import maize or maize products;
- "Grade 1" means sifted granulated maize meal;
- "Grade II" means unsifted granulated maize meal;
- "sound container" means a bag of not less than Grade I second hand quality.

#### Minimum price of maize produced in Swaziland.

- 3. (1) Subject to sub-paragraph (4) and (5), a buyer who purchases maize produced in Swaziland shall pay to the producer or seller not less than E22.50 per bag of 70Kg.
- (2) The producer will receive the difference between the current market buying and selling price for bags, fixed for the coming season at 98 cents and 83 cents respectively.
- (3) The producer will recover 15 cents as a component of the gazetted price for maize and 83 cents from the buyer.
  - (4) Sub-paragraph (1) shall apply only in the case of white maize
    - (a) In a sound container;
    - (b) of a moisture content not exceeding 12½ per centum; and
    - (c) in lots of not less than 30 bags where the producer requires the buyer to transport the maize.
- (5) Where the producer or seller delivers the maize to the buyer at Manzini or any other place authorised by the buyer, the price specified in sub-paragraph (1) shall be increased by the transport charges incurred by him according to the rates specified in the First Schedule.

Maximum retail selling prices of maize meal (Locally produced or imported).

- 4. (1) The maximum retail selling prices of maize meal in quantities of one bag or more shall be as follows;
  - (a) Grade 1 E40.30 per bag of 80Kgs.
  - (b) Grade 2 E38.23 per bag of 80Kgs.
- (2) Subject to sub-paragraph (3) the maximum retail selling prices specified in the Schedules shall apply to the sale of quantities of less than one bag of maize meal.
- (3) If a customer does not supply his own container, the following amounts which shall not be exceeded may be added to the prices specified in the Schedules to cover the cost of containers when maize meal is sold in the following quantities:

Up to 2.3 Kg — 1 cent 2.3. to 4.5 Kg —  $1\frac{1}{2}$  cent 4.5 to 9.1 Kg — 2 cents 9.1 to 13.6 Kg —  $2\frac{1}{2}$  cents
