# THE CHARACTERISTICS OF COINS TO BE ISSUED BY THE CENTRAL BANK OF SWAZILAND NOTICE, 1986

(Under section 24)

In exercise of the powers conferred by section 24 of the Central Bank of Swaziland Order, 1974, the Central Bank of Swaziland with the approval of the Minister for Finance hereby issues the following Notice—

## Citation.

1. This Notice may be cited as the Characteristics of Coins to be Issued by the Central Bank of Swaziland Notice, 1986.

## Currency.

2. The coins to be issued by the Central Bank of Swaziland in terms of this General Notice shall be legal tender within Swaziland in terms of Section 23 of the Central Bank of Swaziland Order, 1974. Coins issued under General Notice No. 97 of 1974 shall continue to be legal tender within Swaziland.

Denominations, Dimensions, Weights and shape of coins.

3. The coins shall consist of Brass-nickel, bronze and copper plated steel coins of the following denominations, material, dimensions, weights and shapes:

1 Lilangeni	Nickel-Brass	22.70	9.50	round milled edge

## Design and Inscription of Coins.

- 4. The coins will bear the following designs and inscriptions.
  - (i) On the observe side of the 1 (one) Lilangeni the 50 (fifty) cents, the 20 (twenty) cents, the 10 (ten) cents, the 5 (five) cents and 1 (one) cent coins shall be engraved and inscribed:-

- (a) in the centre, the image of His Majesty King MSWATI III.
- (b) along the lower edge following the curve of the coin and below the image of His Majesty King MSWATI III the word "SWAZILAND" in capital Roman letters.
- 5. On the reverse side of the Brassnickel coin 1 (one) Lilangeni.
  - (a) in the centre the image of Indlovukazi:
  - (b) along the lower edge following the curve of the coin the word "LILANGENI" in capital Roman letters, to the left of the image the number "1" in Arabic numerals, to the right of the image the year, "1986" in Arabic numerals.
- 6. On the reverse side of the cupronickel coin 50 (fifty) cents:
  - (a) in the centre the image of the official coat of arms of the Government of Swaziland;
  - (b) on top of the official coat of arms of the Swaziland Government the number "50" in Arabic numerals.
  - (c) at the bottom of the official coat of arms of Swaziland Government, and following curve of the coin the word "CENTS" in capital Roman letters, and above the word the year "1986" in Arabic numerals.
- 7. On the reverse side of the cupronickel coin 20 (twenty) cents:
  - (a) in the centre the image of the head of an elephant;
  - (b) on top of the image of the head of an elephant the number "20" in Arabic numerals;
  - (c) at the bottom of the image of the head of the elephant, and following the curve of the coin, the year 1986 in Arabic numerals.
- 8. On the reverse side of the cupronickel coin 10 (ten) cents;
  - (a) in the centre of the image of the top of a sugar cane plant;
  - (b) on top of the image of the top of the sugar cane plant the number "10" in Arabic numerals.
  - (c) at the bottom of the image of the sugar cane plant to the left and following the curve of the coin, the word "CENTS" in capital Roman letters;
  - (d) at the bottom of the image of the top of the sugar cane plant to the right and following the curve of the coin, the year 1986 in Arabic numerals.
- 9. On the reverse side of cupronickel coin 5 (five) cents:
  - (a) in the centre, the image of a flower of Lusekwane plant;
  - (b) above the image of the flower of the Lusekwane plant and the left, the number "5" in Arabic numerals;
  - (c) at the bottom of the image of the flower of the Lusekwane plant to the left and following the curve of the coin the word "CENTS" in capital Roman letters;
  - (d) at the bottom of the image of the flower of the Lusekwane plant to the right and following the curve of the coin the year 1986 in Arabic numerals.

- 10. On the reverse side of the Copper-plated steel 1 (one) cent coin:
  - (a) in the centre the image of a pineapple plant;
  - (b) to the left of the top of the image of a pineapple plant; the number "1" in Arabic numerals;
  - (c) at the bottom of the image of the pineapple plant and to the left following the curve of the coin the word "CENT" in capital Roman letters;
  - (d) at the bottom of the image of the pineapple plant and to the right following the curve of the coin the year 1986 in Arabic numerals.

(Act No. 28 of 1968)

## THE PRICES OF LIQUID MILK NOTICE, 1986

(Under Section 24)

In exercise of the powers conferred by Section 24 of the Dairy Act, 1968 the Minister for Agriculture and Cooperatives, after consultation with the Swaziland Dairy Board hereby issues the following Notice—

Citation and Commencement.

1. This Notice may be cited as the Prices of Liquid Milk Notice 1986 and shall come into force on 18th July, 1986.

Minimum Price to be paid to a Producer of Milk.

2. The price to be paid by a milk processor to a milk Producer for fresh milk delivered by him to such processor shall be not less than 25 cents per litre.

Maximum price to be paid to a milk Processor of fresh cow's milk by a milk Purveyor.

3. The price to be paid by a milk purveyor of liquid milk for fresh cow's milk delivered to him by a processor shall be E1.00 per litre for packaged milk or 98 cents per litre for bulk milk.

Maximum Selling Price of Fresh Cow's Milk.

4. The maximum selling price of fresh cow's milk by dairies, milk shops and milk purveyors to the public shall be E1.04 per litre for cartoned milk or 52 cents per 500 ml.

Maximum Price to be paid to a milk processor of full cream Emasi Emvelo (cultured milk).

5. The price to be paid by a purveyor of Full Cream Emasi Emvelo (cultured milk) delivered to him by a processor shall be E1.00 per litre for packaged cultured milk or 98 cents per litre for bulk cultured milk.

Maximum Selling Price for Full Cream Emasi Emvelo (cultured milk)

- 6. The maximum selling price of cartoned Full Cream Emasi Emvelo (cultured milk) by dairies, milk shops and milk purveyors to the public shall be E1.04 per litre or 52 cents per 500 ml.
- Revocation of Legal Notice No. 5 of 1986.
  - 7. The Prices of Liquid Milk Regulations, 1986 are hereby revoked.

## LEGAL NOTICE NO. 62 OF 1986

## THE COTTON ACT, 1967

(Act No. 26 of 1967)

# THE COTTON (DESTRUCTION AND PLANTING DATES) REGULATIONS, 1986

(Under sections 10 and 17)

In exercise of the powers conferred by sections 10 and 17 of the Cotton Act, 1967, the Minister for Agriculture and Co-operatives after consultation with Cotton Board, hereby makes the following Regulations:-

## Citation.

1. These Regulations may be cited as the Cotton (Destruction and Planting Dates) Regulations, 1986.

Dates before which cotton plants to be destroyed.

2. The 30th August, 1986 is the date for the whole of Swaziland before which all cotton plants shall be destroyed.

## Method of destruction.

- 3. The method of destruction to be used by growers for their cotton plants under these Regulations shall be as follows:-
  - (a) the removal of the upper portion of the plant by severing it at a point not more than 10 cm above the surface of the ground and the burning of the portion so removed;
  - (b) by means of an agricultural implement, so lacerating and burying the plant as to prevent its regrowth;
  - (c) by ploughing in or causing to be destroyed any portion of the cotton plant which remains above the surface of the ground before the 1st December, 1986.

## Default in destruction.

- 4. (1) The owner of land on which is grown a cotton plant to be destroyed as required by regulation 3 shall ensure that the grower complies with these Regulations.
- (2) If a grower or an owner fails to comply with regulation 3 the Principal Secretary Ministry of Agriculture and Co-operatives or the Cotton Board may cause the cotton plants to be destroyed and recover from the grower the full expense of the destruction.

## Planting of cotton.

5. No cotton shall be planted before the 15th October, 1986.

## Penalties.

- 6. If a grower or owner:-
  - (a) fails to destroy a cotton plant as required by regulation 3; and
  - (b) plants cotton in contravention of regulation 5, he shall be guilty of an offence and liable on conviction to a fine not exceeding One hundred Emalangeni or imprisonment for a period not exceeding three months, and the court may order the destruction of such plants within such time as it may determine.

Revocation of Legal Notice No. 77 of 1986.

7. The Cotton (Destruction and Planting Dates) Regulations, 1985 are hereby revoked.
