THE DAIRY ACT, 1968  
(Act No. 28 of 1968)

LEVY ON MILK AND DAIRY PRODUCTS REGULATIONS, 1987  
(Under Section 25)

In exercise of the powers conferred by section 25 of the Dairy Act 1968, the Minister for Agriculture and Co-operatives, after consultation with the Dairy Board, hereby makes the following regulations:

*Citation.*

1. These Regulations may be cited as the Levy on Milk and Dairy Products Regulations, 1987 and shall come into force on the 1st of June 1987.

*Levies to be paid by Producers and Importers of Milk.*

2. All importers of milk and all producers of milk produced in Swaziland save and except such producers who sell all their milk to the processing plant of the Swaziland Dairy Board, shall pay the following levies:

- (a) 5 cents per litre of milk produced.
- (b) 10% of the invoice value of imported milk.

*Levies to be paid by Manufacturers and Importers of Dairy Products.*

3. All manufacturers and Importers of dairy products shall pay the following levy: viz. 10% of the invoice value of the imported dairy product.

3(a) All imports of dairy products must be supported by the necessary import permit as required by Section 18 of the Dairy Act.

*Repeal of Legal Notice No. 72 of 1978.*

4. Legal Notice No. 72 of 1978 is hereby repealed.

THE WORKMEN'S COMPENSATION ACT, 1983  
(Act No. 7 of 1983)

THE WORKMEN'S COMPENSATION (AMENDMENT) REGULATIONS, 1987  
(Under sections 12 and 44)

In exercise of the powers conferred by sections 12 and 44 of the Workmen's Compensation Act, 1983 the Minister for Labour and Public Service hereby makes the following Regulations —

*Citation.*

1. These Regulations may be cited as the Workmen's Compensation (Amendment) Regulations, 1987 and shall be read as one with the Workmen's Compensation Regulations, 1983 (hereinafter called "the principal Regulations").

*Amendment of Regulation 3.*

2. Regulation 3 of the principal Regulations is replaced with the following —

"3. (1) For the purpose of ascertaining whether a deceased workmen left any dependants and if so the degree to which they were dependent on the earnings of the deceased workman, the Commissioner of Labour shall, as soon as practicable, make such enquiries as may be appropriate and furnish a certificate of dependency setting out his findings in the form prescribed in Part I of the Schedule hereto.

(2) Where it appears to the Commissioner of Labour that a person in another country may be entitled to claim compensation as a dependant of the deceased workman and sufficient evidence of the dependency of that person cannot be procured without undue hardship to that person, the Commissioner of Labour shall arrange for a supplementary certificate to be furnished by a magistrate of that other country."
