# THE REGULATION OF WAGES (SECURITY SERVICES INDUSTRY)

(AMENDMENT (NO. 2)) ORDER, 1990

(Under Section 11)

In exercise of the powers conferred upon him by Section 11 of the Wages Act, 1964, the Minister for Labour and Public Service hereby make the following order:

#### Citation and Commencement.

1. This order may be cited as the Regulation of Wages etc and shall be deemed to have come into force on the 1st January, 1990.

2. The First Schedule to the Regulation of Wages (Security Services Industry Order, 1990) is hereby amended by replacing the figure "250.97" appearing against "group D" with the figure "282.56".

# **COMMISSION OF ENQUIRY ACT 1963**

(Act No. 35 of 1963)

# THE COMMISSION OF ENQUIRY INTO THE ROAD TRANSPORTATION BOARD AND ROAD TRANSPORTATION APPEALS BOARD NOTICE, 1990

(Under Section 3)

In exercise of the powers conferred upon me in terms of Section 3 of the Commission of Enquiry Act of 1963, I Wilson F.C. Mkhonza, Minister for Works and Communications hereby issue the following notice:

#### Citation.

1. This notice may be cited as the Commission of Enquiry into the Road Transportation Appeals Board Notice 1990.

# Establishment of Commission.

- 2. (1) There is hereby issued and established a Commission to be known as the Commission of Enquiry into the Road Transportation Board and Road Transportation Appeals Board hereinafter referred to as "The Commission".
- (2) The Commission is empowered to hold enquiry in any location deemed appropriate or as it sees—fit but may regard the principal place to convene as the Ministry of Works and Communications Head Office Conference Room.
  - (3) The Commission shall be composed of the following members:
    - (1) Mr. Douglas Lukhele who shall be the sole Commissioner
    - (2) Mr. John Kunene who shall lead evidence
    - (3) Mr. Caiphas Mahlalela who shall be the Secretary.

## Terms of Reference.

3. (1) The Commission shall examine and enquire into the activities of the Road Transportation Board and the Road Transportation Appeals Board for the period 1st April 1987 to 31st March, 1990 or such other earlier or later period as the Commission may consider relevant.

It shall without prejudice to the generality of the foregoing enquire particularly into:

- (a) The procedures used in granting permits including regulations to control passenger and cargo cross-border commercial traffic;
- (b) the adherence by the two Boards to the laws regulating their activities;
- the adequacy or otherwise of the laws regulating road transportation service in Swaziland and or the powers of the Boards;
- (d) the volume of applications for permits;
- (e) the record-keeping system in the Road Transportation Board secretariat and the Road Transportation Appeals Board;
- (f) the oversupply of permits and route congestion/closure;

- (g) the position of Swaziland Railway in the road transportation service, with particular regard to its interest in the goods transport industry;
- (h) the adequacy of permit fees; and
- (i) the personnel complement in the Road Transportation Board Secretariat.
- (2) The Commission shall further:
  - (a) Examine and enquire into any other matter relating to road transport activities which may be regarded as irregular or detrimental to the interest of the public; and
  - (b) make any recommendations it finds appropriate based on its findings.

Commencement Date and Duration of Commission.

- 4. (1) The Commission shall commence its work on 17th April, 1990, and submit its report not later than 20th July, 1990.
- (2) The Minister may by notice in the Gazette extend the period for the Commission to submit its report.
