An Act to amend the Road Traffic Act, 1965.

ENACTED by the King and the Parliament of Swaziland.

*Short title.*

1. This Act may be cited as the Road Traffic (Amendment) Act, 1990 and shall be read as one with the Road Traffic Act, 1965 (hereinafter referred to as "the principal Act").

*Amendment of Section 10.*

2. Section 10 of the principal Act is amended in paragraph (a) of subsection (6) by replacing it with the following –

“(6) (a) allot to the motor vehicle in question a configuration of numbers and letters as the Minister may, by regulation prescribe and, if so directed by the Minister allot such insignia as the Minister specifies to be in addition to, or in lieu of those letters and numbers; and”

CROWN LANDS DISPOSAL ACT, 1911

(Act No. 13 of 1911)

THE MBABANE (EXTENSION NO. 20) (AMENDMENT)  
REGULATIONS, 1990

(Under Section 12)

In exercise of the powers conferred by Section 12 of the Crown Lands Disposal Act, 1911 the Minister for Natural Resources and Energy hereby makes the following Regulations -

*Citation and Commencement.*

1. These Regulations may be cited as the Mbabane (Extension No. 20) (Amendment) Regulations, 1990 and shall be read as one with the Mbabane (Extension No. 20) Regulations, 1990 (hereinafter referred to as "The Principal Regulations") and shall be deemed to have come into operation on the 31st March, 1978.

*Amendment of Paragraph 2.*

2. Paragraph 2 of the Principal Regulations is amended by replacing -

- (I) the figures "52/86" wherever they appear with the figures 53/86;
- (II) the words "24th day of July, 1986" with the words "25th June, 1986".
