THE LOAN (MATSAPHA INDUSTRIAL PARK) ACT, 1990

(Act No. 4 of 1990)

AN ACT

entitled

An Act to authorise the Minister for Finance to raise a loan for financing the rehabilitation and extension of the infrastructure of the Industrial Park in Matsapha as well as a management assistance of the Ministry of Commerce, Industry and Tourism.

ENACTED by the King and the Parliament of Swaziland

Short title

1. This Act may be cited as the Loan (Matsapha Industrial Park) Act, 1990.

Interpretation.

- 2. In this Act unless the context otherwise requires -
 - "Agreement" means the Agreement referred to in section 3 and includes any document related thereto;
 - "Borrower" means the Government of the Kingdom of Swaziland;
 - "Lender" means Kreditanstalt Für Wiederaufbau (KFW);
 - "loan" means the loan raised by the Minister under section 3;
 - "Minister" means the Minister responsible for Finance.

Authority to raise loan.

3. The Minister for Finance is hereby authorised to enter into an Agreement with the Lender for the purpose of raising a loan not exceeding seventeen million and five hundred thousand Deutsche Marks (DM17,500,000), approximately twenty-six million Emalangeni (26,000,000) upon the terms and conditions specified in this Act and upon such other terms and conditions as the Government may consider appropriate.

Loan charges repayments.

- 4. (1) The Borrower shall repay the loan in thirty (30) years in sixty-one (61) consecutive semi-annual instalments commencing from 30th June, 2000 and ending on 30th June 2030.
- (2) The loan shall carry an interest at the rate of three quarters of one per cent (0.75%) per annum.
- (3) The Borrower shall pay to the Lender a commitment charge of one quarter of one per cent (0.25%) per annum on the undisbursed loan amounts, and the commitment charge shall be computed for a period beginning three (3) months after the signing of the Agreement and ending on the respective dates of disbursements of the loan.
- (4) The Borrower shall pay to the Lender the commitment charge, the interest and the interest on arrears of repayment, if any, semi-annually on 30th June and 31st December respectively.

Charging of loan.

5. The loan shall be charged upon the Consolidated Fund and the assets of the Government.

Application of loan.

6. The proceeds of the loan shall be used for financing the rehabilitation and extension of the infrastructure of the Industrial Park in Matsapha as well as a management assistance to the Ministry of Commerce, Industry and Tourism.

(Act No. 35 of 1963)

THE COMMISSION OF ENQUIRY INTO THE SALARIES AND BENEFITS PAYABLE TO OFFICERS ON GRADES 24 AND ABOVE IN THE CIVIL SERVICE NOTICE, 1990

In exercise of the powers conferred upon me by Section 3 of the Commissions of Enquiry Act, 1963, I, BEN M. NSIBANDZE, Minister for Labour and Public Service hereby issue the following Notice –

1,. This Notice may be cited as the Commission of Enquiry into the Salaries and Benefits payable to officers on Grades 24 and above in the Civil Service Notice, 1990.

Establishment and composition of Commission.

- 2. (1) There is hereby established a commission to be known as the Commission of Enquiry into the Salaries and Benefits payable to officers on Grades 24 and above in the Civil Service (hereinafter called "the Commissioner").
 - (2) The Commission shall consist of -
 - (a) Mr T.G. Masina Chairman
 - (b) Mr C.M.E. Dlamini Member
 - (c) Mr .A.H. Fandam Member
 - (d) Mrs. N. Hlope Secretary
 - (3) Two members of the Commission including the Chairman shall constitute a quorum.

Functions of the Commission.

- 3. (1) The Commission shall examine and enquire into the salaries and benefits currently payable to officers on grades 24 and above in the Civil Service and shall without prejudice to the generality of the foregoing, enquire particularly into the extent if any, to which such officers have been disadvantaged, in terms of salary scales and other benefits by—
 - (a) the incomplete implementation by the government of the accepted recommendations of the 1986 Hlophe Commission appointed to enquire into the structure, conditions of service and remuneration of the Public Service;
 - (b) the subsequent alterations to the original recommendations of the 1988 Richard's Salaries Review Commission; and
 - (c) the subsequent reductions of the pay award granted to officers on grades 24 and above by the government and promulgated in Establishment Circular No. 7 of 1990.
 - (2) The Commission shall further -
 - examine and enquire into any other matter relating to the subject matter of this enquiry as it may consider relevant;
 - (b) make any recommendations it finds appropriate based on its findings, with a view to resolving the problem and correcting any situation that may have disadvantaged the officers concerned.

Enquiry venue.

4. The enquiry shall be held at the Ministry of Education Offices in Mbabane at such times as the Chairman may determine.

Enquiry in Camera.

5. The enquiry shall be held in camera.

Duration of Enquiry.

6. The Commission shall commence its function with immediate effect and shall submit a its report to the Minister for Labour and Public Service by 31st October, 1990 or on such later date as the Minister may permit in writing.

THE VIDEO (EQUIPMENT, ACCESSORIES AND CASSETTES) REGULATIONS, 1990

(Under Section 26)

Citation and commencement.

1. These Regulations may be cited as the Video (Equipment, Accessories and Cassettes) Regulations, 1990, and shall be read as one with the Video (Equipment, Accessories and Cassettes) Regulations, 1986 (hereinafter referred to as "the principal Regulations") and shall come into force on the 1st September 1990.

Amendment of regulation 13.

- 2. Regulation 13 of the principal Regulations is amended by replacing paragraph 1 (c) with the following -
 - "(c) contravenes regulation 10 or 11 shall be guilty of an offence and liable on conviction to a fine not exceeding E500.00 or imprisonment for five months or both".
