#### THE FUEL OIL LEVY BILL, 1991

(Bill No. 5 of 1991)

(To be presented by the Minister for Natural Resources and Energy)

#### MEMORANDUM OF OBJECTS AND REASONS

The object of this Bill is to repeal and re-enact with amendments the Fuel Oil Levy Act, 1980 and:

- (a) to empower the Minister for Natural Resources and Energy in consultation with the Minister for Finance to impose a levy on fuel oil;
- (b) to provide for the establishment, in addition to the Strategic Oil Reserve Fund, of a Road Fund to be used for the maintenance of public roads and road bridges as well as making improvements to road safety signs on public roads;
- (c) to provide for the transfer of a specified amount from the Oil Fund to the Road Fund; and
- (d) to provide for other incidental matters.

# A BILL entitled

An Act to repeal and re-enact with amendments the Fuel Oil Levy Act, 1980. ENACTED by the King and the Parliament of Swaziland.

#### Short title and commencement.

1. This Act may be cited as the Fuel Oil Levy Act, 1991 and shall come into force on such day as the Minister may by Notice in the Gazette appoint.

#### Interpretation.

- 2. In this Act unless the context otherwise requires:
  - "authorized officer" means any person authorized by the Minister to perform any of the functions of carrying out the purpose of this Act;
  - "fuel oil" includes petrol, diesel oil, aviation gasoline, kerosene, residual fuel oil, naphtha, base oil, products of base oil, grease or petroleum gas;
  - "levy" means a levy imposed under section 3 of this Act;
  - "Minister" means the Minister responsible for Natural Resources and Energy;
  - "prescribed" means prescribed by regulation under Section 13 of this Act;
  - "repealed Act" means the Fuel Oil Levy Act, 1980 as amended;
  - "supplier" means any company specified in the Schedule to this Act.

#### Power of Minister to impose levy.

- 3. (1) The Minister may, in consultation with the Minister for Finance, by Notice published in the Gazette impose on any fuel oil a levy at such rate as may be specified in that Notice.
- (2) The levy shall be charged, levied, paid and collected from the date of its imposition in respect of every amount and in relation to the type of fuel oil specified in the Notice under subsection (1) of this section.

#### Purpose for the levies.

- 4. (1) The levy shall be used for the purposes specified in sections 9 and 10 in relation to the Strategic Oil Reserve Fund and the Road Fund respectively.
- (2) The moneys raised from any levy as well as any interest payable thereon by virtue of section 6 shall be invested in the Oil Fund and the Road Fund respectively in such manner and in such amount as the Minister may, in consultation with the Minister for Finance, determine.

#### Method of collection and payment of levies.

5. Every levy collected by a supplier shall be paid to the Government of Swaziland in accordance with regulations made under section 13 of this Act.

#### Interest on unpaid levies.

6. Any person who fails to pay to the Government of Swaziland within the time prescribed any levy collected by him shall be liable to pay interest on the amount of any payment or part thereof, not made on the due date, calculated at such rate as may be prescribed and any such amount together with the interest payable thereon shall be treated as debt owed by that person to the Government.

#### Refund of levies.

- 7. Any levy which is paid on fuel oil obtained for the exclusive use of:
  - (a) the King and the Ndlovukazi;
  - (b) diplomatic missions, international organizations or institutions and members of the diplomatic staff entitled to exemption from dues and taxes under the Diplomatic Privileges Act, 1968; or
  - (c) such other class of persons as the Minister may by Notice published in the Gazette specify,

shall be refunded on application made under section 8 of this Act.

#### Method of refund of levies.

8. Any person who is entitled to a refund of any levy under section 7 may claim such refund in accordance with such regulations as may be prescribed.

#### Establishment of Strategic Oil Reserve Fund.

- 9. (1) There is hereby established a fund to be known as Strategic Oil Reserve Fund, referred to in this Act as the "Oil Fund".
- (2) The amount of money accruing from the levy and which is invested in the Oil Fund under section 4 shall be used—
  - (a) for the financing of any increase in cost of purchasing fuel oil;
  - (b) for or in connection with the purchase, acquisition, distribution, sale, saving, conservation, storage, utilization of fuel oil or the carrying out studies intended to facilitate the supply of fuel oil products to Swaziland

#### Establishment of Road Fund.

- 10. (1) There is hereby established a Fund to be known as the "Road Fund".
- (2) The amount of money accruing from the levy and which is invested in the Road Fund under section 4 shall be used for the maintenance of public roads and road bridges as well as improvement to road safety signs on public roads.

#### Transfer of part of moneys invested in Oil Fund to the Road Fund.

11. Without prejudice to section 4, the moneys raised by virtue of the increase in the levy by 4 cents per litre imposed on fuel oil under section 3 of the repealed Act with effect from 1st April, 1968 until the commencement of this Act and which have been invested in the Oil Fund established under the repealed Act shall, on the coming into force of this Act, be transferred from that fund to the Road Fund.

#### Offences and penalties.

- 12. (1) Any person who—
  - (a) fails to pay any levy within the time prescribed;
  - (b) fails to provide any information or return required under this Act;
  - (c) knowingly makes a false statement in relation to such information or return;
  - (d) fails to record or perform any function prescribed by this Act;
  - (e) obstructs any authorised officer in the performance of his duty under this Act;commits an offence.
- (2) Any person convicted of an offence under this section shall be liable to a fine not exceeding five thousand Emalangeni or to imprisonment not exceeding six months or to both.

#### Regulations.

13. The Minister may by Notice published in the Gazette make such regulations as he deems necessary for the better carrying out of the purpose of this Act including regulations for the proper management of the Oil Fund and Road Fund established under sections 7 and 8 of this Act.

Amendment of Schedule.

- The Minister may by Notice published in the Gazette amend the Schedule to this Act.
   Repeal.
- 15. The Fuel Oil Levy Act, 1980 and the Fuel Oil Levy (Amendment) Act, 1981 are hereby repealed.
