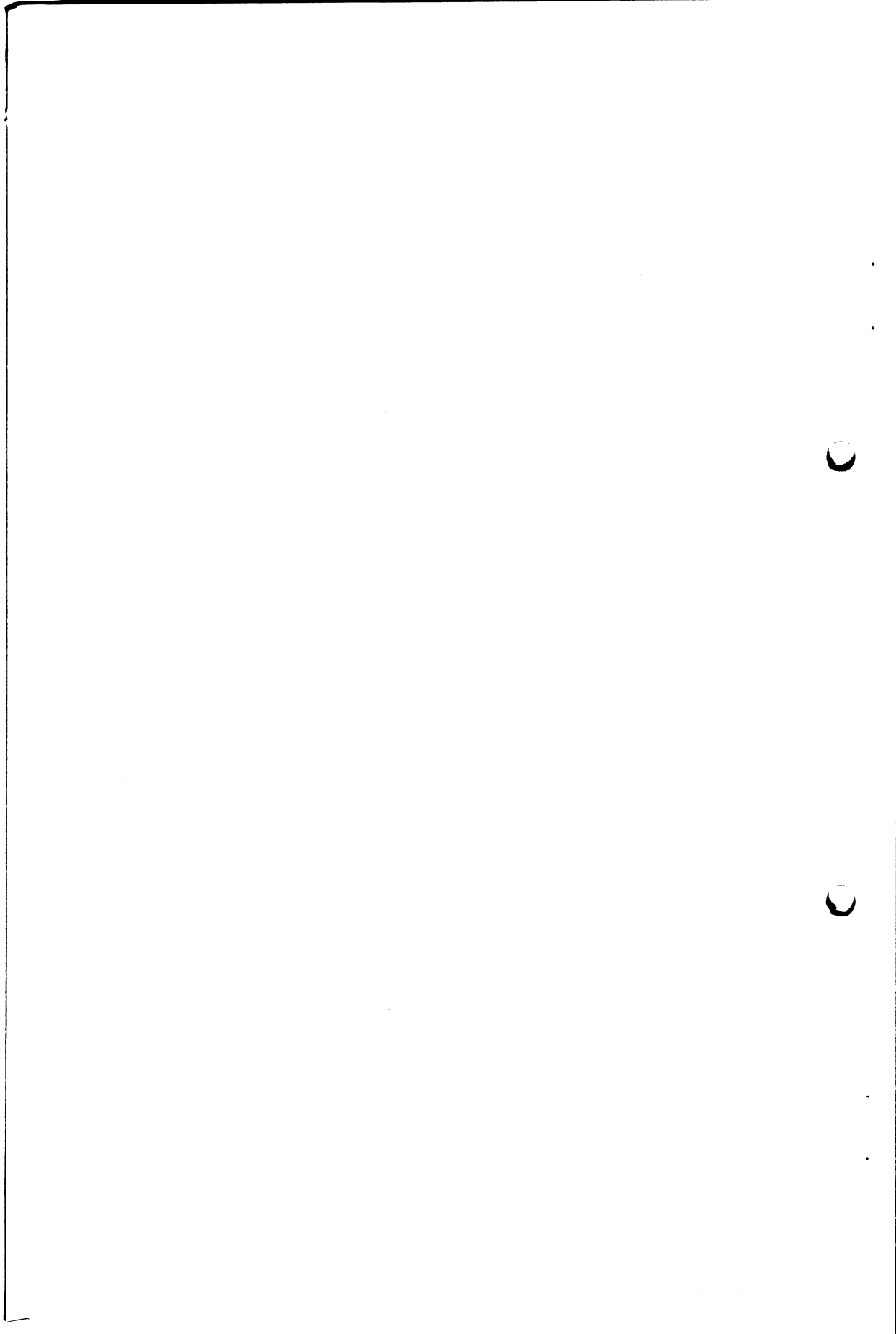

THE SWAZILAND POSTS AND TELECOMMUNICATIONS

(Act No. 11 of 1983)

THE PUBLIC TELECOMMUNICATIONS REGULATIONS, 1993

(Under Sections 63 and 76)

In exercise of the powers conferred by Section 63 and 76 of the Swaziland Posts and Telecommunications Act, 1983 the Minister for Transport and Communications hereby makes these Regulations.

## PART I - PRELIMINARY PROVISIONS

*Citation and Commencement.*

1. These Regulations may be cited as the Public Telecommunications Regulations, 1993 and shall be deemed to have come into force on.

*Interpretation.*

2. In these Regulations, unless the context otherwise requires"

"Agreement" means an agreement entered into between the Corporation and a Subscriber in terms of Regulation 11;

"Act" means the Swaziland Posts and Telecommunications Act 1983;

"Automatic party Line" means a Telephone Installation Line with Subscriber Dialling access to and from Local Automatic System, rented for the use of more than two Subscribers and to which the Corporation may connect additional Subscribers at its discretion;

"Board" means the Board of Directors of the Corporation appointed under Section 4 of the Act;

"Call" means a communication between two terminals by means of a Telecommunications System;

"Circuit" means a connection between one place and another place whereby the transmission at a distance of and reception of signs, signals, writings, images and sounds or intelligence of any nature is possible by electromagnetic systems either along wires or cables joining those places or partly by wires and cables and partly by radio communication or wholly by radio communication;

"Convention" means an International Telecommunication Convention and its annexed regulations for the time being in force and to which Swaziland is a party and also any modifications of any agreements or regulations made under the convention from time to time concerning Telecommunication Services;

"Corporation" means the Swaziland Posts and Telecommunications Corporation established under Section 3 of the Act;

"Direct Exchange Line" means a Telecommunication Line connecting only one Subscriber's terminal with an exchange;

"Directory" Means

- (a) A directory containing names, addresses, telephone numbers and telegraph numbers and answer-back codes of subscribers within Swaziland and published by the Corporation; and
- (b) A supplement to such a directory or directories;

"Exchange" means a telecommunications exchange operated by the Corporation and comprising apparatus by means of which telecommunications may be provided;

"External Extension" means a line rented by a subscriber to connect his direct exchange line termination or switching unit served by such termination in a building to a point outside that building;

"Fixed Time Trunk Call" means a trunk call booked in advance for connection at or about a specified time;

"Internal Trunk Call" means a telecommunication call between exchanges within Swaziland which are not in the same minimum rental area;

"International Trunk Call" means a telecommunications call at any other country;

"Local Call" means a call between two terminals -

- (a) Connected to the same exchange; or
- (b) Connected to different exchanges in the same Minimum Rental Area or between two teleprinters connected directly to the teleprinters in Swaziland;

"Manual Party Line" or "IMPL" means a manually operated telephone line for the use of more than one subscriber and to which the Corporation may connect additional subscribers at its discretion;

"Minimum Rental Area" or "MRA" means -

- (a) Any area specially defined as such in the Post Office Guide, or
- (b) Any area within a distance of one and a half kilometers of any telephone exchange other than a telephone exchange situated within an area specially defined as such in the Post Office Guide;

"PABX" means private automatic branch telephone exchange;

"Party Line" means a telephone line for use by more than one subscriber as prescribed in the Post Office Guide;

"Private Branch Exchange" means an automatic exchange (PABX) or a manual exchange (PMBX) connected to the public telecommunications network;

"Privately Owned Telecommunication Line" means a telecommunication line not owned by the Corporation and which is not connected to the public network;

"Private Wire" means a telecommunication line and associated apparatus established and maintained by the Corporation which does not communicate with or through a public telephone or teleprinter exchange or telegraph office;

"Rental" means the amount prescribed as the charge for a telecommunication line or apparatus maintained by the Corporation;

"Service" means facilities for the transmission and reception of calls by means of telecommunications lines, instruments, exchange facilities and other means provided by the Corporation;

"Shared Service Line" means a telecommunication line shared by two subscribers;

"Subscriber" means a person who has entered into an agreement with the Corporation under these regulations for the provision of service;

"Telecommunications" means any transmission, emission or reception of signs, signals, writings, images and sounds or intelligence of any nature by wire, radio, optical or other electro-magnetic systems;

"Telecommunications House" means any house, building or place used for purposes of telecommunication services by the Corporation;

"Telegraph" means the transmission and reproduction at a distance of documentary matter, such as written or printed matter or fixed images, or the reproduction at a distance of any kind of information in such a form, by means of electric signals from one place to another place either along a wire joining those two places, or wholly by radio communication;

"Telegraph Line" means any circuit used for the purpose of a telegraph service;

"Telegraph Services" means the services performed and facilities provided in connection with the transmission of communications by means of telegraph apparatus;

"Telephone" means the transmission at a distance of speech, or in some cases other sounds by means of electricity from one place to another place either along a wire joining those two places or partly by wire from each of those two places and partly by radio communication, and also an instrument used or intended to be used by any person transmitting or receiving any communication by means of telephone services;

"Telephone Line" means any circuit used for the purpose of a telephone service and any apparatus connected therewith;

"Telephone Services" means the services performed and facilities provided in connection with the transmission of spoken communications or in some cases of other sounds by means of telephone or other apparatus;

"Telex" means a system whereby information is exchanged between teleprinters via a public switched network;

"Telex Apparatus" or "Telex Installation" means a teleprinter and associated equipment which is installed at a subscriber's premises and connected by a circuit to a public teleprinter's exchange;

"Telex Call" means a telegraphic communication arranged between teleprinters connected to the same or different teleprinter exchanges;

"Telex Line" means any circuit used for the purpose of the telex service;

"Telex Service" means a teleprinter exchange service by means of which -

- (a) A subscriber may communicate telegraphically directly and temporarily by teleprinters with another subscriber connected to the same or another teleprinter exchange;
- (b) A subscriber may send printergrams telegraphically to a telegraph office, and receive telegrams by teleprinters from a telegraph office;

"Tie Line" means a circuit connecting two private terminals utilized by the same subscriber;

"Trunk Call" means any call other than a local call;

"Zone Centre" means a geographical point in Swaziland which shall be the measuring point for international trunk call charge purposes,

*Application of these Regulations.*

3. These regulations shall not apply to any telecommunication line and associated apparatus licensed under the Private Telecommunications and Wires Regulations 1992 and which does not communicate with or through a public exchange.

## PART II

### ESTABLISHMENT OF TELECOMMUNICATIONS SERVICES

*Exclusive Rights of Corporation.*

4. The Corporation shall have the exclusive right -
  - (a) To establish, maintain and operate telecommunications services within Swaziland and between Swaziland and other countries;

(b) To determine:

- (i) The conditions, and subject to the approval of the Minister the rates payable by subscribers for use of those services and;
- (ii) The terms under which any person may construct, maintain and operate private telecommunications facilities and services.

*Establishment of Exchange System.*

5. The Corporation may establish telecommunication exchanges at such points as may appear to it desirable, and may open subsidiary exchanges or group a number of exchanges as may be expedient.

*Allotment of Numbers and Transfer Lines to other Exchanges.*

6. (1) The Corporation may connect a subscriber to any exchange, and allot or vary the number of a subscriber's line from the exchange to which it is connected to any other exchange.

(2) In the event of such transfer the rental payable shall not be increased during the period of the subscriber's agreement.

*Call Rental and Installation Charges and Fees.*

7. (1) The Corporation shall prescribe charges in respect of calls, rentals and installations and these charges may vary according to the exchange with which the subscriber is connected, the distance from the exchange or measurement centre, the type of service provided and any special requirement of the subscriber.

(2) Where the rental is wholly or partly dependent on distance the Corporation's decision on the measurement of distance and length of line shall be final.

(3) All charges and fees prescribed by the Corporation shall be published in the Post Office Guide and these may be varied by the Corporation from time to time.

(4) Services for which no specific charges are prescribed in the Post Office Guide shall be charged for at such rates as the Corporation may determine.

*Service Outside MRA.*

8. (1) The Corporation may provide telecommunication outside a minimum rental area and may prescribe special rates and conditions for such service.

(2) The decision as to what type of line should be provided in accordance with the requirements of these regulations shall be taken by the Corporation having regard to the equipment available at the exchange concerned.

*Privately Owned Lines and Equipment.*

9. (1) No person shall erect or maintain a privately owned telecommunication line and equipment without the permission of the Corporation.

(2) The Corporation may grant such permission or a Licence under the Private Telecommunications and Wires Regulations, 1992 and on such other conditions as it may think fit, or may refuse such permission or licence without giving its reason for so doing.

*Removal of Equipment Owned by the Corporation.*

10. All apparatus and connecting wires owned by the Corporation may be removed by the Corporation upon termination of the Agreement with the subscriber.

## PART III

## PROVISION OF SERVICE: AGREEMENTS

*Agreements for Service.*

11. (1) The Corporation may enter into an agreement with any person for the hire to such person or body of telecommunication apparatus and for the maintenance and service thereof in accordance with the conditions specified in these regulations and on payment of the rentals fees and charges prescribed.

(2) The Corporation may enter into an agreement for the hire of telegraph apparatus and for the maintenance and service thereof with any person wishing to become subscriber to the telegraph service.

(3) No telecommunication apparatus shall be hired to any person and no service shall be provided in respect thereof unless such person -

- (a) Has signed an agreement in a form prescribed by the Corporation undertaking to be bound by the provisions of these regulations, including the payment of the rentals, fees and charges prescribed from time to time by the Corporation;
- (b) Has paid, if so required by the Corporation the prescribed installation or transfer charges;

(4) The prescribed rental in respect of an initial period shall be from the date of commencement of service until the end of the calendar year or for such longer period as may be determined by the Corporation, and specified in a special agreement to be entered into prior to the commencement of service.

(5) Where service is required on premises in which a complete installation exists the subscriber's minimum rental shall cover any unexpired balance of the period of the agreement fixed with the previous subscriber.

(6) The Corporation may require a subscriber to deposit with the Corporation such amount as it may determine.

(7) If any applicant for a telecommunication service is not the owner of the premises in which a terminal is to be intalled, the Corporation may refuse to install the terminal unless the applicant has obtained the permission of the owner of the premises, or if the applicant is a sub-lessor, of the person in whom is vested the right of occupation of the premises, and has indemnified the Corporation against the expense of all necessary works in connection with such installation.

(8) An agreement under this regulation in respect of a telephone installation comprising a PABX shall be subject to the following conditions:

- (a) Any person wishing to install a PABX shall apply to the Corporation furnishing such information as will enable the Corporation to calculate the telephone traffic (initially and ultimate) and the number and type of direct exchange lines to be provided;
- (b) The Corporation may -
  - (i) Decide that such PABX system, together with junction and tie lines, as in its opinion will be appropriate to satisfy the requirements of the applicant shall be installed by the Corporation subject to sub-regulation (3); or
  - (ii) Require the applicant to purchase or hire and to have installed at the applicant's expense such PABX system, made by a manufacturer whose equipment is approved by the Corporation.

- (c) After the installation of a private PABX in accordance with paragraph (b) (II), and before it is connected to an exchange, an inspection and series of tests shall be undertaken by the Corporation to ensure that the component parts are correctly interconnected, the equipment is properly installed and that it functions satisfactorily;
  - (d) The Corporation may refuse to connect the PABX to the Corporation system until it has approved the standard of installation and its decision in this regard shall be final;
  - (e) The subscriber shall pay to the Corporation the charges presented for inspection and testing, and in addition shall pay the charges prescribed for inspection and testing of the PABX;
  - (f) The Corporation shall maintain in good working order any PABX leased under paragraph (b) (I), and the cost prescribed for the routine maintenance shall be included in the annual rental charge;
  - (g) The subscriber shall maintain in good working order a PABX installed at his expense whether under paragraph (b) (II) or prior to the coming into force of these regulations:  

Provided that the Corporation may, upon giving one year's notice in writing to the subscriber assume responsibility for its routine maintenance and the costs of which shall be included in the annual rental charge;

And provided further that when parts of a privately owned PABX have to be replaced for any cause whatsoever the replacement parts shall be supplied by the subscriber who shall, if so required by the Corporation, keep such stock of component parts as the Corporation may require;
  - (h) The cost of electrical power required to operate the PABX shall be paid by the subscriber direct to the supplier of the electrical power and if the Corporation considers that a special equipment is necessary because of excessive fluctuation in the power supply to the PABX, the cost of providing and installing such equipment shall be borne by the subscriber;
  - (i) The Corporation may require a subscriber to bear the cost of any alterations to a private PABX necessitated by any change or development of the Corporation's exchange system.
- (9) An agreement under this regulation in respect of the installation of a telegraph apparatus shall be subject to the conditions specified in sub-regulation (7).
- (10) The subscriber shall -
- (a) Provide at his own expense, if necessary, suitable tables on which the terminal and associated apparatus may be placed at terminal and intermediate points;
  - (b) Provide at his own expense and use in a terminal only paper of quality, type and size approved by the Corporation and also ensure at all times that there is adequate supply of such paper in the terminal apparatus;
  - (c) Arrange at his own expense for the provision of a proper electrical power supply which shall be continuously available, terminating on an approved type of three-point socket adequately earthed, and with a suitable plug to match the socket, the power point being for the exclusive use of the terminal apparatus and placed at a distance of not more than two metres from the teleprinters and apparatus;
  - (d) Keep his terminal apparatus permanently switched on except in case of temporary suspension of service and shall give the Corporation twenty four (24) hours' notice in writing of his intention to suspend and switch off or shall otherwise inform the Corporation as soon as practicable if the apparatus is switched off or is out of



commission for any reason whatsoever.

*Periods of Agreements.*

12. (1) Except as otherwise provided in this regulation, an agreement shall be valid for one year.
- (2) The period of an agreement in respect of a PABX or for a plan telephone system, a non-standard installation or a standard installation, where special difficulties occur, or a temporary connection, shall be such period as the Corporation may determine and specify in the agreement.
- (3) Where an exchange line and apparatus already exist in the premises of a subscriber and are available for allocation, the period of an agreement shall be one year or the unexpired period of the previous subscriber's agreement, whichever is the greater.
- (4) Where a new agreement is necessary by reason of a change in the name or designation of the subscriber and the original agreement has not expired, the period of the new agreement shall be the unexpired period of the original agreement.
- (5) Where a new agreement is necessary by reason of the transfer of a telecommunication apparatus to a new address, and the original agreement has not expired, the duration of the new agreement shall be that applicable to the installation at the new address or the unexpired period of the original agreement, whichever is the greater.

*Renewal of Agreements.*

13. Unless the agreement is terminated in writing by the Corporation or the subscriber, if upon the expiration of the agreement the subscriber does not apply for renewal thereof but pays the rental and any other charges prescribed the agreement shall be deemed to have been renewed for the period for which such rental and charges are paid.

*Non-Transfer of Agreements.*

14. Agreements shall not be transferable from one person to another.

*Alteration of name or designation of subscriber.*

15. If the name or designation of a subscriber is changed, such subscriber shall enter into a new agreement with the Corporation.

*Termination of Agreements.*

16. (1) Any agreement renewed under regulation 13 may be terminated at any time if thirty days' notice in writing to that effect is given by either the Corporation or the subscriber:

Provided that the Corporation may waive such period of notice if it is necessary that the agreement be terminated and a new agreement entered into an account of:

- (a) A change in the name or designation of the subscriber; or
- (b) The transfer of the Telecommunication apparatus to a new address,

(2) If an agreement in respect of which the rental has been paid in advance is terminated before its expires, the Corporation may refund or allow on account to the subscriber the unexpired portion of the rental after allowance has been made for the period of notice required under sub-regulation (1):

Provided that no portion of the rental paid or payable in respect of the initial period of the agreement shall be refunded, waived or allowed on account to the subscriber except in the circumstances referred to in subregulation (3) or (4).

(3) Where a connection is transferred without removal of apparatus to a new subscriber approved by the Corporation, the whole of the unexpired rental shall be refunded to the original subscriber subject to the settlement by the original subscriber of all charges due, and any additional

rental which would otherwise be payable in respect of the initial period of the agreement shall be waived.

(4) Where an agreement is terminated and a new agreement entered into for any of the reasons mentioned in the proviso to sub-regulation (1) the whole of the unexpired rental already paid shall be allowed on account to the subscriber in respect of the new agreement, and any additional rental which would otherwise be payable in respect of the initial period of the new agreement shall be waived.

*Discontinuance of the Telecommunication Lines.*

17. The use of any telecommunication line may be discontinued on the expiration of the subscriber's agreement or at any time thereafter if either party gives to the other a month's notice in writing.

*Joint User.*

18. (1) The Corporation may permit any subscriber to the telecommunication service to allow any other person to use his terminals.

(2) The subscriber shall be responsible for all fees and charges incurred by the joint user and shall also pay the joint user fee as prescribed.

*Installation Charges*

19. (1) A telecommunication apparatus may not be installed unless the installation charges prescribed has been paid by the subscriber.

(2) Installation charges shall not be refunded in whole or in part,

(3) If in any building (other than a dwelling house) erected after the commencement of the Act no conduit pipes or other facilities for the installation of telecommunication equipment are provided in that building or part of such building, the Corporation may -

- (a) Refuse to provide telecommunication services in that building or any part thereof until such conduct pipes or other facilities have been so installed;
- (b) Provide the telecommunication services in that building or in any part thereof, and in addition to the fees prescribed for the provision of such services charge for the installation of the telecommunication equipment an amount by which the costs of installation in the opinion of the Corporation exceed the costs which would have been incurred if those conduit pipes or other facilities had been installed in the building.

(4) The Corporation may defer the rendering of an account for the prescribed charges in respect of subsequent installation of a telecommunication apparatus until the apparatus has been installed and service has been provided, but such charges shall then be payable within the period prescribed in regulation 74.

*Public Call offices and private premises.*

20. A public call office telephone unit (coin box) may, on application be installed at the discretion of the Corporation subject to the following conditions:

- (a) No calls shall be put through from the public call office telephone until the fees due are deposited in the coin box;
- (b) The proprietor or manager of the premises on which a coin box is installed must guarantee prompt attention to inward calls at the public call office telephone;
- (c) The application may be required to provide a suitable telephone unit cabin and in all cases the telephone unit shall be placed in a position approved by the Corporation;

- (d) The applicant shall agree to pay for the cost of repairs to or replacement of apparatus and wires damaged by fire or other cause while the telephone is being installed on his premises;
- (e) Authorised officers of the Corporation shall have access to the apparatus and connecting wires for the purpose of their maintenance at any time during which the premises are normally open;
- (f) The telephone unit shall be available for use by the general public and the applicant may be required by the Corporation to exhibit a notice bearing the words "Public Telephone;"
- (g) The Corporation may remove the telephone unit whenever it is necessary to do so.

#### PART IV

#### GENERAL CONDITIONS OF AGREEMENTS

##### *Free Access to subscriber's premises.*

21. An authorised officer of the Corporation shall have free access at all reasonable times to the premises of any subscriber for the purpose of inspecting or maintaining or for the purpose of removing such apparatus, when service is discontinued.

##### *Maintenance of lines and apparatus.*

22. Except where an agreement expressly stipulates and subject to subregulation (5) of regulation 11, the payment of rental shall cover the maintenance in working order of the telecommunication apparatus.

##### *Interruption of Service.*

23. (1) A telecommunication installation shall be considered to be in working order unless the Corporation is notified to the contrary by the subscriber.

(2) Where a subscriber's apparatus is not in good working order the Corporation shall, unless there is an express agreement to the contrary, restore it without charge provided that:

- (a) The Corporation shall not, in any circumstances, be liable to the subscriber in damages or otherwise for any delay in restoring the service, or for any loss or damage caused by the total or partial interruption thereof;
- (b) There shall be no rebate of the rental prescribed on account of such failure or omission unless the service has been totally interrupted for a continuous period of not less than fourteen days following such notification under subregulation (1), in which case the Corporation may allow a partial rebate of the annual charge.

##### *Refusal of service.*

24. (1) The Corporation may refuse to provide telecommunication service:

- (a) Where suitable facilities for the purpose are not available;
- (b) To any person whose telecommunication facilities have been disconnected in accordance with these regulations for any default or offence;
- (c) If it considers that the provision of such telecommunication service is contrary to the public interest;
- (d) Where the provision of such service is, in the opinion of the Corporation, likely to interfere with other telecommunication services provided by the Corporation; or

- (e) To a telegraph forwarding agency which is known to be organized for the purpose of sending or receiving telegraphy with a view to evading the full charges due for the complete route,

(2) The Corporation may refuse a subscriber the use of an international telecommunication service if the activity of such subscriber is regarded an infringement of the Corporation's function to provide public telecommunication service.

*Precautions against damage to subscriber's premises.*

25. (1) The Corporation shall take all reasonable precautions to prevent injury or damage to subscribers or their premises from fire or other cause arising from the installation and working of telecommunication connection, but shall not be liable for any damage or injury which may arise from the failure of taking any such precautions.

(2) The Corporation shall not enter into an agreement with any person to install a telecommunication apparatus in a premises with a thatched roof unless that person:

- (a) Enters into a special agreement with the Corporation whereby the Corporation is indemnified and held harmless against any claim for damages due to fire caused by the connections to such premises; or
- (b) Agrees to bear at his expense the cost of a special entrance cable.

*Subscriber's liability for damage to apparatus.*

26. Without prejudice to the provisions of the Act or any other provisions of these regulations, a subscriber shall pay on demand to the Corporation the cost of making good any damage not due to fair wear and tear of any apparatus installed by the Corporation or any wiring within his premises or under his control, whether or not such damage has resulted from the negligence or wilful act of any person or from fire or other cause.

*Attachments to telecommunication apparatus.*

27. (1) No subscriber shall cause or permit any attachment to be made to the telecommunication apparatus hired to him or anything to be placed in electrical connection therewith or anything to be placed or used in such a manner or position in relation to such apparatus that it transmits or enables to be transmitted a message or other communication to or from such apparatus unless the Corporation has granted permission therefore by entering into a special agreement with him under regulation 28.

(2) Where the Corporation has granted such permission the subscriber shall be responsible for -

- (a) Any damage caused to the telecommunication apparatus hired to him; and
- (b) Any fault in connection with the service;

Which is due to an attachment having been made or a thing having been connected, placed or used in the manner mentioned in subregulation (1).

*Special agreement for certain attachments to telecommunication apparatus.*

28. (1) The Corporation may in accordance with the conditions specified in this regulation and subject to payment of the charges and fees prescribed, enter into a special agreement with a subscriber permitting the subscriber to make an attachment to the telecommunication apparatus hired to him or to place a thing in electrical connection therewith or to use or place a thing in such a manner or position in relation to such apparatus that it transmits or enables to be transmitted any message or other communications to or from such apparatus.

(2) Where a special agreement entered into under subregulation (1) is in force, the subscriber shall, before reporting any fault in connection with the service, cause tests to be carried out to verify that the fault is not due to an attachment having been made or a thing having been connected placed or used as mentioned in subregulation (1).

(3) A special agreement entered into under subregulation (1) may be terminated at any time after the Corporation or the subscriber has given thirty days' notice in writing to that effect.

(4) On the termination of a special agreement in accordance with the provisions of subregulation (3) -

- (a) The Corporation shall refund or allow on account to the subscriber in respect of the unexpired portion of the special agreement;
- (b) The subscriber shall forthwith cease to use and shall remove anything which has been attached, connected, placed or used as mentioned in subregulation (1).

*Improper use of Telecommunications Apparatus.*

29. (1) The Corporation may without prior notice to the subscriber terminate an agreement if -

- (a) Without the written approval of the Corporation the subscriber allows his telecommunication apparatus to be used otherwise than -
  - (i) For his own business or private purpose; or
  - (ii) For or on behalf of any guest residing or boarding with him;
- (b) The Corporation is satisfied that the subscriber has charged in respect of any calls made by or on behalf of such a guest an amount in excess of the charge prescribed for such call;
- (c) The subscriber allows the telecommunication apparatus hired to him to be wilfully damaged or destroyed or put to any improper or illegal use including, as regards telex apparatus, using it for the purpose of sending or receiving telegrams for retransmissions by telegraphy with a view to evading the full charges due for the complete route;
- (d) Any telecommunication apparatus or its connections hired to a subscriber are tampered with or altered without written authorisation of the Corporation;
- (e) Improper language is used over the subscriber's telecommunication circuit to an exchange operator or any other person;
- (f) The subscriber contravenes or fails to comply with the provisions of paragraph (b) on regulation 27 (1) or regulation 28 (4); and this is without prejudice to any other penalty that may be prescribed by any law for such offence.

(2) Where a subscriber permits his telephone circuit to be used by any other person and charges such person for a call an amount in excess of the charge prescribed for such call, the Corporation may give notice in writing to the subscriber requiring him to install such metres, or such additional metres as are in the opinion of the Corporation necessary for recording the prescribed charges payable for such calls.

(3) If the subscriber fails to comply with such notice within one month of its receipt by him, the Corporation may terminate the agreement at any time thereafter having given notice in writing to that effect to the subscriber.

(4) Upon termination of the agreement for any of the reasons stated in this regulation, the Corporation may remove the name of the subscriber from the directory and enter upon the premises of the subscriber for the purpose of removing all the telecommunication apparatus belonging to the

Corporation, and such steps shall in no way prejudice the right of the Corporation to take such further steps as it may deem necessary for the recovery of all amounts due from the subscriber.

(5) Upon removal of the telecommunication apparatus under subregulation (4), the Corporation shall in addition to any sums due, be entitled to recover forthwith from the subscriber as liquidated damages and not by way of penalty a sum equal to any rental which remains unpaid in respect of any term of the agreement subject to the provisions of regulation 77.

*Vacated Premises.*

30. If a subscriber vacates his premises and fails to notify the Corporation in writing the Corporation may remove the telecommunication apparatus without prejudice to its claim for any amount which may be due from the subscriber.

*Suspension of service during temporary absence.*

31. (1) A subscriber who does not desire to abandon his telecommunication number during his temporary absence, may request the Corporation in writing to disconnect his telecommunication apparatus or otherwise suspend the service by the removal of the apparatus.

(2) Where in accordance with the request of the subscriber -

- (a) The telecommunication apparatus is disconnected and left on his premises, the subscriber shall pay the reconnection fee prescribed when the apparatus is reconnected;
- (b) The apparatus is removed from the subscriber's premises for safe custody the subscriber shall pay the normal installation charge prescribed when the service is restored.

(3) No suspension of rental or refund of any portion of rental already paid shall be made in respect of a telecommunication apparatus disconnected or removed in accordance with this regulation.

*Transfer of telecommunication apparatus.*

32. (1) The Corporation may on application by the subscriber remove the telecommunication apparatus installed on the subscriber's premises from one position to another or to another address served by the exchange.

(2) The Corporation may -

- (a) Require payment of the prescribed transfer charge before the telecommunication apparatus is so transferred; or
- (b) At its discretion defer the rendering of an account for the prescribed transfer charge until the telecommunication apparatus has been so transferred and service has been provided;

But in all cases charges shall be payable within the period prescribed in regulation 74,

(3) Where considered necessary by the Corporation the subscriber may in addition be required to enter into a new agreement,

*Rearrangement of APLs and MPLs.*

33. The Corporation may -

- (a) Increase or decrease the length of any existing APL or MPL and the number of subscribers connected to such line;
- (b) Rearrange existing lines and connections to such lines in any way it deems fit and adjust rentals for such rearranged line connections in accordance with the charges prescribed.

*Transfer of lines to other exchanges.*

34. The Corporation may at any time transfer a subscriber's line from the exchange to which it is connected and reconnect it to any other exchange.

Provided that the rental shall not be increased during the period the agreement remains valid.

*Subsidiary exchanges and exchange system.*

35. The Corporation may establish a subsidiary exchange at any point or group the exchanges in any area to form one or more telephone exchanges.

*Allotment of number and exchange names.*

36. The Corporation may in its discretion allot or vary at any time a subscriber's telephone number or any other service number and answer back code or the name of the exchange to which a subscriber's line is connected and shall be liable for any loss or inconvenience resulting from such allotment or variation.

*Adequacy of telecommunication lines for traffic.*

37. (1) If congestion on a telecommunication line is such that in the opinion of the Corporation the line cannot carry the traffic required of it during busy hours, the Corporation may give the subscriber notice in writing requiring him to send such number of additional exchange lines as are necessary to meet the requirements of the telecommunication traffic to and from such subscriber and, as the case may be, to agree to the conversion of one or more lines to uni-directional operation.

(2) If the subscriber fails to comply with such notice within one month of its receipt, the Corporation may at any time thereafter immediately terminate the agreement by notice in writing to the subscriber.

(3) If in the opinion of the Corporation the number of calls to the exchange on a party line is excessive it may terminate the party line agreement and require the parties to rent such direct exchange lines as it may deem necessary or it may discontinue the service,

*Shared service lines.*

38. The Corporation may on payment of the prescribed fees and charges provide shared service telecommunication lines at places where the exchange is equipped with suitable apparatus, and the premises of the parties are located within a reasonable distance of each other.

*Tie Lines.*

39. (1) The Corporation may provide a tie line connection to two private branch exchanges at the prescribed charges subject to the following conditions -

- (a) Such tie line shall only be provided for the use of the same subscriber or for the subscriber and an affiliated body; and
- (b) Both private branch exchanges shall be in the same exchange area.

(2) For the purpose of this regulation, the question whether an undertaking is an affiliated body of the subscriber, shall be determined by Corporation.

*External Extension Lines.*

40. The Corporation may in its discretion extend an exchange line externally to the subscriber's second office, or residence at the prescribed tariff rates.

*Switching of calls at subscriber's premises.*

41. Where a telecommunication installation at a subscriber's premises includes facilities for switching calls, the subscriber shall provide an attendant to operate such switching calls.

*Hours of Service.*

42. Service shall be provided at manual exchanges during such hours as may be determined by

the Corporation.

*Service at exchanges operated by agents.*

43. Where a telecommunication line terminates at any exchange at which no officer of the Corporation is employed the Corporation shall endeavour to employ a suitable person as telecommunication agent and shall pay such person reasonable remuneration for the performance of telecommunication switching duties:

Provided that where the cost is higher than the Corporation considers reasonable the Corporation may require the subscriber whose lines are connected to that exchange to pay an increased rental.

## PART V

### RENTALS

*Amount of Rentals.*

44. A subscriber shall pay to the Corporation the amount of the rental prescribed in respect of the service and apparatus provided by the Corporation

*Determination of distance and routes.*

45. The measurement of distance, lengths of line for rental purposes and routing of telecommunication lines shall be determined by the Corporation.

*Rental payment.*

46. The Corporation may defer the rendering of an account for the first rental in respect of a new agreement until after service has been provided, but such rental shall be payable within the period prescribed in regulation 75.

*Non-payment of first rental.*

47. (1) If a subscriber fails to pay his first rental under regulation 46 (2) and within the period prescribed in regulation 75, the Corporation may without notice to the subscriber suspend the service, cancel the agreement, remove the name of the subscriber from the directory and enter upon the subscriber's premises for the purpose of removing all the apparatus belonging to the Corporation and such steps shall in no way prejudice the right of the Corporation to take such further steps as it may deem necessary for the recovery of the amount due.

(2) Upon removal of the telecommunication apparatus the Corporation may recover forthwith from the subscriber in addition to the arrears as liquidated damages and not by way of penalty a sum equal to any rental which remains unpaid in respect of any period of the agreement subject to the provisions of regulation 77.

## PART VI

### CALLS

#### A - ALL TELEPHONE CALLS

*Charging for calls on automatic telephone Exchange subscribers.*

48. (1) All calls dialled by an automatic telephone exchange subscriber to another subscriber shall be metered in units at a prescribed rate per unit.



(2) Where there is a discrepancy between the units as registered in respect of a subscriber on a meter in the exchange and on the meter installed on the subscriber's premises the reading on the exchange meter shall be accepted as the true reading.

*Repayment of charges.*

49. The Corporation may claim repayment for any call or payment for any previous calls, before allowing another.

*Limitation of duration of telephone calls.*

50. The Corporation may terminate any telephone call after the expiration of six minutes from the time of its commencement.

*Transfer of calls.*

51. Subject to the payment of the charge prescribed and at the discretion of the Corporation, a subscriber with a direct line to an automatic telephone exchange may have incoming calls transferred to another number or to the same automatic exchange: provided that automatic exchange has the necessary equipment.

*Time Calls.*

52. Persons wishing to know the correct time may obtain this information from an exchange at alarm call at the charge prescribed.

*Alarm Calls.*

53. A subscriber wishing to be called from the exchange at a specified time may book an alarm call at the charge prescribed.

*Collect Calls.*

54. (1) A caller making a local or internal trunk telephone call or an international trunk telephone call in areas where collect calls are admitted, may request the exchange operator to have the charge prescribed for such call collected from the person called.

(2) A fixed extra charge for a collect call shall be levied in addition to the unit charge for the call or the tariff applicable when the call matures, and shall be payable by the subscriber to whose telephone the call is made.

(3) Where a person service facility is also provided in conjunction with the collect service, a personal service charge shall be payable in addition to the unit charge and the collect call service charge, but as the personal service charge must be defrayed by the caller, it shall be debited to the account of the subscriber who books the call.

(4) If the call is booked from a call office, the personal service charge shall be paid by the caller at the time that the call is booked.

(5) If the called subscriber refuses to pay for the call and the caller offers to pay the cost, the collect call charge shall be payable by the called subscriber.

(6) If both the caller and the called subscribers refuse to pay for the cost of the call, the call shall be cancelled and no charge shall be levied except that the personal service charge shall be payable.

(7) Nothing in this regulation shall be construed as permitting the charge prescribed for a call to be collected from the person called where such person receives the call at a public call office telephone.

B - INTERNAL AND INTERNATIONAL TELEPHONE  
TRUNK CALLS

*Recording of Trunk Calls.*

- 55 (1) Any person booking a call shall, on request by the exchange operator -
- (a) Furnish the number of the telephone from which he is calling; and
  - (b) Give the exchange and number required.
- (2) If a "personal" call is required, the name of the person called shall also be given.

*Charging for effective trunk calls.*

56. (1) Except in the case of a personal service call or messenger service call, a call shall be regarded as effective when communication has been established between the calling and the called telephone, whether or not particular persons are available.

(2) The Corporation may provide any automatic exchange subscriber whose telephone is connected to a direct exchange line with the facility of dialling trunk calls directly to such exchanges as it may determine, and any trunk call so made shall be charged for on a time basis at the prescribed rates.

*Enquiries regarding charge and or duration of trunk calls.*

57. (1) A caller may require that he should be informed of the charge or duration or both the charge and duration of a completed manually switched trunk call.

(2) The charge for such service shall be as prescribed for every request per call.

*Limitation of bookings.*

58. The Corporation may limit the number of consecutive bookings of trunk calls by any one person.

*Notification of elapsed time on trunk calls.*

59. On trunk calls controlled by exchange operators, callers may be notified of the termination of each three minutes of elapsed time, when it is possible to do so:

Provided that failure to give such notification shall not confer any right on the caller to claim a deduction in the amount of the charge made.

*Originating subscriber engaged on a local call when a trunk call matures.*

60. (1) When a trunk call is established and the originating subscriber is found to be engaged on a local call, the exchange operator may break into the local connection and inquire whether the trunk call may be put through.

(2) If the originating subscriber refuses to receive the trunk call, the local connection shall be restored but the trunk call may be regarded as a complete call and charged for accordingly.

*No reply from originating number.*

61. If there is no reply from the telephone of the originating subscriber when a trunk call is established such subscriber may be charged for the call provided that the failure of the originating subscriber to receive the call is not due to a fault on his line or apparatus.

*Fixed time trunk calls.*

62. (1) Subject to conditions stated in this regulation and on payment of the prescribed charge, a trunk call may be booked not more than two working days in advance for connection at or about a specified time.

(2) Fixed time trunk calls may be booked either instantly or by a standing order for a call at a specified time every day for a period of not less than one week (excluding or including Saturdays, Sundays and public holidays) at the option of the caller.

(3) If a fixed time trunk call is cancelled by the caller -

- (a) Not less than ten minutes prior to the fixed time, no charge shall be made for the booking;
- (b) Less than ten minutes prior to the fixed time, the caller shall be charged the amount prescribed for a fixed time call of three minutes duration to the exchange to which the call was booked.

(4) If the connection for a fixed time trunk call is not made within thirty minutes of the fixed time no charge shall be made for the booking.

(5) The Corporation shall not be liable for any loss or inconvenience resulting from failure to connect a fixed time trunk call at the fixed time.

*Personal service trunk calls.*

63. (1) A call may be booked for connection to a particular person designated by name or other description, or to a particular department or to a code number or extension number.

(2) A personal service charge, as prescribed shall be paid, in addition to the other call charges, if connection is established in accordance with the booking and the timing shall not commence until such communication is established.

(3) A personal service charge shall also be paid if communication cannot be established in accordance with the bookings, and in such circumstance be treated as ineffective: provided that if communication cannot be established with the number required, the Corporation may waive the personal service charge.

*General conditions.*

64. In all matters concerning internal trunk calls and international trunk calls which are not specifically mentioned in this part, ordinary practice as prescribed in operating procedures and agreements with telecommunication administrations or authorised agencies of other countries shall apply.

C - INTERNATIONAL TELEPHONE TRUNK CALLS

*Extent of service.*

65. International trunk calls may be made to such countries and ships at sea as the Corporation may determine in accordance with the conditions specified in this part.

*Conditions of service restrictions.*

66. International trunk calls may not normally be originated from a public call office telephone or from such exchange lines as the Corporation may deem unsuitable for the connection of international trunk calls:

Provided that such calls may be originated at a supervised call office telephone installed in or at a post office.

*Chargeable duration of international trunk calls.*

67. The duration of an international trunk call in respect of which a charge may be levied shall be determined by the Corporation.

*Sending and receiving telegrams through the telex service.*

68. (1) The subscriber to a telex service may transmit telegrams to a telex office designated by the Corporation.

(2) Such messages, which are known as printergrams shall be accepted upon payment of the prescribed charge.

(3) Telegrams sent to a subscriber from a telex office shall be transmitted free of charge.

*Duration of telex calls.*

69. (1) The duration of any telex call shall be determined from the time that the required connection is established.

(2) The Corporation may terminate any telex call after the expiration of fifteen minutes from the time the required connection is established.

*Call interruptions.*

70. If any telex call is interrupted or rendered difficult or ineffective because of line or apparatus failure the Corporation may allow the calling subscriber a reasonable extension of time without additional charge of refund to the subscriber such portion of the charge payable as the Corporation may determine.

*Report charge.*

71. (1) A report charge as prescribed shall be levied in respect of an international call if -

- (a) A subscriber refuses to accept call previously booked but not cancelled; or
- (b) No reply can be obtained from the subscriber who booked the call when the connection is established and the failure to reply is not due to a fault on the subscriber's line or apparatus.

(2) If a subscriber gives a wrong number to an operator when booking an international call and the call is connected, the charge for the wrong call shall be the minimum charge prescribed for a call to the called teleprinters exchange, unless the wrong call is replaced immediately by a call to another subscriber in the same country in which case the charge for the wrong call shall be the same as report charge as prescribed.

*The International Telex Service.*

72. (1) The charges for the operation of, and the general conditions relating to, the international telex service and any supplementary or other services in connection with it shall be determined in accordance with:

- (a) The Convention; or
  - (b) Such arrangements as the Minister may have entered into in accordance with the Act.
- (2) The Corporation shall give notice of:
- (a) The places where international telex services are in operation;
  - (b) The supplementary and other services, if any, which are to be provided, and
  - (c) Any changes in the conditions as are contained in these regulations.

PART VII

ACCOUNTS

*Subscriber's Liability.*

73. A subscriber shall be responsible for the payment of all charges arising out of the use of his telecommunication apparatus, whether such charges have been incurred with or without his knowledge or permission.

*Subscriber's dialled trunk calls.*

74. (1) Charges for telephone trunk calls dialled direct by a subscriber shall be included in the telephone calls account under the heading of "metered calls."

(2) The Corporation may not provide details of any telephone trunk call dialled by a subscriber, nor subdivide the total metered calls to show the cost of those which are trunk calls and those which are not trunk calls.

(3) The Corporation may not waive any charges due in respect of the total metered calls made by a subscriber.

*Payments of accounts.*

75. (1) Where a subscriber fails to settle any account within the period prescribed in this regulation, the Corporation may, without notice to the subscriber suspend the service to subscriber and this shall in no way prejudice the right of the Corporation recover any amount which may be due at the time of the suspension, or any incidental expenses connected therewith.

(2) If, after a further period of thirty days the subscriber's account remains unpaid, the Corporation may cancel the agreement, remove the name of the subscriber from the directory and enter upon the premises of the subscriber for the purpose of removing all the apparatus belonging to the Corporation, and such steps shall in no way prejudice the right of the Corporation to take such further steps as it may deem necessary for the recovery of the amount due.

(3) Upon removal of the telecommunication apparatus, the Corporation shall be entitled to recover forthwith from the subscriber, as liquidated damage and not by way of penalty a sum equal to any rental which remains unpaid in respect of any term of the agreement subject to the provisions of regulation 78.

(4) The Corporation may refuse service for any period it may deem fit to any subscriber who is often in arrears with the payment of his accounts.

*Non-payment of accounts.*

76. (1) Where a subscriber has failed to pay an account within the period prescribed in regulation 74, the general Corporation Manager may summarily suspend the service to the subscriber without prejudice to the Corporation's right to recover any amount which may be due at the time of the suspension or which may accrue during the period of suspension.

(2) If, after a further period of thirty days the subscriber's account remains unpaid, the Corporation may cancel the agreement, remove the name of the subscriber from the directory and enter upon the premises for the purpose of removing all the apparatus belonging to the Corporation and such steps shall in no way prejudice the right of the Corporation to take such further steps as it may deem necessary for the recovery of the amount due.

(3) Upon removal of the telephone or telex apparatus the Corporation shall be entitled to recover forthwith from the subscriber, in addition to the arrears a sum as liquidated damages and not by way of penalty equal to any rental which may remain unpaid in respect of any term of the agreement subject however to the provisions of regulation 77.

(4) The Corporation may refuse service for any period it may deem fit to any subscriber who is found to be frequently in arrears with the payment of his accounts.

*Deposits*

77. (1) Before any line or apparatus is hired out to any person, the Corporation may require that person to deposit with the Corporation a specified amount and when the service is discontinued, the balance, if any, shall be refunded after all deductions have been made in accordance with these regulations.

(2) The Corporation may require a subscriber to deposit such sum in respect of call charges, phonograms, printergrams and supplementary services as the Corporation may prescribe and if the subscriber defaults in the payment of such deposit the Corporation may decline to render any service to the subscriber unless he has prepaid the charges for such service.

(3) Where a subscriber fails to pay any amount due under these regulations by him to the Corporation, the Corporation may deduct the amount from any deposit paid by the subscriber and may require the subscriber to make up the deposit with the amount deducted therefrom.

*Payment for restoration of suspended service.*

78. (1) Where a subscriber's service has been suspended because of non-payment of any account under these regulations it shall be restored only on payment of the total outstanding amount together with the reconnection charge prescribed.

(2) When a subscriber's account remain unpaid after the period of suspension of his service the telecommunication apparatus shall be removed and shall be reinstalled only after the subscriber has paid in full the total amount outstanding together with the charges prescribed for the removal and reinstallation of telecommunication apparatus.

PART VIII

TELECOMMUNICATIONS DIRECTORIES

*Issue.*

79. The Corporation shall arrange for the periodic issue to subscribers on the conditions specified in this part of directories and of such supplements to the directories as it may deem necessary.

*Copyright.*

80. The copyright of a directory is the property of the Corporation and all right therein are reserved.

*Accuracy.*

81. The Corporation shall not be liable for any loss or inconvenience to a subscriber resulting from any errors or omissions in a directory.

*Distribution and charges.*

82. (1) A subscriber shall be entitled to one free copy per rented telecommunication apparatus of each issue of the directory for telephone or telex as the case may be.

(2) The charge for extra copies of the directory or for copies of a directory relating to another country shall be as prescribed.

*Ownership.*

83. A directory issued free of charge to a subscriber remains the exclusive property of the Corporation and shall be surrendered to any duly authorized officer of the Corporation on demand.

*Cover.*

84. A subscriber shall not be permitted to display any advertisements on the cover of a directory.

*Entries.*

85. Entries made in the directories shall be subject to the conditions set out in the schedule to these regulations.

*Revocation.*

86. (1) The telephone regulations, 1962 are hereby revoked.

(2) Notwithstanding subregulation (1) any service agreement subsisting between the Corporation and any subscriber before the commencement of these regulations shall continue to be in force subject to the provisions of these regulations.

SCHEDULE  
(REGULATION 85)

*Conditions relating to entries in telecommunication directories.*

- (1) Except with the permission of the Corporation or as provided for in this schedule -
  - (a) Every subscriber is required to have a directory entry;
  - (b) Only subscribers may have telecommunication directory entries,
- (2) The Corporation shall have the right -
  - (a) To refuse, abbreviate, curtail, amend or cancel any entry relating to a subscriber at any time prior to the printing of the directory,
  - (b) To determine the call number and answer-back code that must be inserted in the telex directory in respect of each subscriber.

*Entries in alphabetical sections.*

3. The provisions of paragraphs 5 to 15 shall apply to entries in the main alphabetical section of the telephone directory and to the telex directory or any other service directory.

*Free Entitlement .*

4. (1) Every subscriber shall be entitled to a free entry in the directory in ordinary type and except as provided in paragraph 8, a free entry shall be limited in the case of -
  - (a) One telephone exchange connection, to one line of type;
  - (b) One telex connection, up to two lines of type;
  - (c) Two or more telecommunication exchange connections, to two lines of type except that where three or more different telecommunication numbers are separately listed in one entry, the subscriber shall be entitled to not more than three lines of type free of charge;
- (2) A telephone subscriber shall furnish the following particulars -
  - (a) Surname together with any appropriate designation such as "Mrs," "Miss," "Rev," "Dr," "Judge," "Hon," "Sir," "Lord," "Earl," etc, or generally recognized title, or subject to paragraph 7, a Trade or Brand name;
  - (b) Forenames or personal names or initials;

- (c) Decorations, degrees, qualifications, etc., denoted by letters;
- (d) In addition to the subscriber's name or business or Trading title, or a trade name as provided in this paragraph, not more than three words descriptive of the subscriber's business or occupation;
- (e) Number or name of premises or both Number and Name of premises.
- (f) Street or suburb or district or both street and suburb or district where premises are situated;
- (g) Postal district number;
- (h) Post Office Box Number;
- (i) Registered telegraphic address;
- (j) Particulars such as "Residence," "Surgery," "Consulting Rooms," "Managing Director," "General inquiries," "Accounts," etc., (Abbreviated as necessary);
- (k) Telephone number.

(3) A subscriber to the telex service shall furnish the following particulars:

- (a) The particulars mentioned in subparagraph (2), (a), (b), (c), (d), (e), (f), (g), (j), and the name of the town and the subscriber's call number and answer back code.

(4) If after making all reasonable abbreviations, the essential information necessary for purposes of identification cannot in the opinion of the Corporation be contained in the number of free lines of type to which the subscriber is entitled under sub-paragraph (6), the subscriber shall be allowed one extra line of type free of charge.

(5) Unless the Corporation decides otherwise in any particular instance, the following particulars will not be regarded as constituting essential information necessary for the purpose of identification -

- (a) Forenames or personal names in full except where there are two or more subscribers with the same surname and initials;
  - (b) Decorations, degrees, qualifications etc., denoted by letter, other than "M.P."
  - (c) Words descriptive of a subscriber's business or occupation;
  - (d) Postal district number;
  - (f) Registered telegraphic address;
  - (g) Particulars such as "Residence," "Survey," consulting room, "Managing Director," "General inquiries," "Accounts," etc., or abbreviations thereof, except when those particulars are necessary to distinguish between two or more separate telephones.
- (6) A Trade or Brand name may be included free of charge in any entry if -
- (a) The subscriber is the manufacturer or sole distributor or holds the sole agency right for the commodity in question in the area covered by the telephone exchange with which the telephone is connected;
  - (b) The Trade or Brand name comprises the first word or words of the entry; and
  - (c) The Trade or Brand name is the registered name of the commodity.

*Additional lines in ordinary type.*

6. In the case of any entry in ordinary type which is restricted to the particulars specified in subparagraph (6) but which exceeds the free line entry permitted under paragraph 4 (1) and (6), the publisher may charge the subscriber for each line or part thereof in excess of the free entry at a rate



not exceeding the maximum rate specified in paragraph 14.

*Additional particulars.*

7. A telephone subscriber may request the publisher to include in an entry any of the following particulars:

- (a) General commodity particulars;
- (b) Particulars indicative of or relating to the subscriber's business or occupation;
- (c) Provided that -
  - (i) No such entry printed wholly in ordinary type shall exceed six lines; and
  - (ii) Subject to this paragraph and paragraph 4 (6), such particulars shall not comprise the first word or note is of any entry; and
  - (iii) Subject to this paragraph and paragraph 4 (6) the inclusion of such particulars shall be the whole entry charged at a rate not exceeding the maximum rate specified in paragraph 14.

*Additional entries.*

8. A telephone subscriber may have one or more additional entries made in ordinary type in the alphabetical section of the Telephone Directory and such entry or entries shall conform to the provisions of paragraphs 4 (6) and 7 provided that such additional entries shall be solely in respect of the business or occupation of the subscriber, or member of subscriber's own family resident with him.

9. No subscriber may have more than two consecutive entries commencing with the same name and relating to the same installation.

10. Additional entries shall be arranged by the subscriber with the Corporation and the charge for each additional entry shall be payable to the Corporation at the rate prescribed.

11. (1) A subscriber may have all or part of an entry printed in bold type subject to the following provision.

- (a) Except in the case of sub-headings and cross references specifically inserted or permitted by the Corporation where a bold type is included in an entry the publisher shall charge for the whole entry;
- (b) No entry with the name or trading title of a subscriber or a Trade or Brand name printed in bold type shall exceed five lines in addition to the line or lines containing bold types; and
- (c) such bold type shall be in upper case only.

(2) Any subscriber who wishes to have all or part of any entry printed in bold type shall notify the publisher in writing sending a copy of his request to the Corporation, and the arrangements for the entry shall be concluded directly between the subscriber and the publisher.

*Maximum charges levied by the publisher.*

12. The maximum rates chargeable for entries in the directories shall be -

- (a) As prescribed for each chargeable line or part thereof in ordinary type in each issue of the directory;
- (b) such amount as agreed upon between the subscriber and the publisher for each line or part

*Alterations.*

13. A subscriber shall notify the Corporation in writing of any necessary alterations or corrections in his name, address or other particulars, as printed in the alphabetical section of the Telephone Directory and in the telex directory.

*Entries in classified sections.*

14. All entries in that section of the directory in which the entries are classified according to the trades or professions of the subscribers shall be charged at such rates as agreed upon between the subscriber and the publisher.

15. An application for the insertion of any entry in the classified section of the directory shall be made to the publisher of the directory and the acceptance of any such application shall be subject to the approval of the publisher and to payment by the subscriber of the charge agreed upon.

*Payment of charges to the published.*

16. If in terms of this schedule an entry is wholly or partly chargeable over and above the free entitlement for additional entry allowed under paragraph 9, the charges shall be payable to the publisher.

*Closing date for entries and change to entries.*

17. The Corporation may from time to time publish notice of the closing date for entries and changes to entries in the directories.
