LEGAL NOTICE NO. 35 OF 1993

THE DAIRY ACT, 1968

(Act No. 28 of 1968)

THE PRICES OF LIQUID MILK AND EMASI NOTICE OF 1993

In exercise of the powers conferred upon him by Section 24 of the Dairy Act No. 28 of 1968, the Minister for Agriculture and Cooperatives, after consultation with the Swaziland Dairy Board hereby issues the following Notice.

Citation and Commencement.

- 1. This Notice may be cited as the Prices of liquid Milk and Emasi Notice of 1993 and shall be deemed to have come into force on the 1st October, 1992.
- 2. The price to be paid by a milk processor to a milk producer for fresh cow's milk delivered by him to such processor shall not be less than 70 cents per litre.

Maximum price to be paid to a milk Processor for fresh Cow's milk Purveyor.

3. The price to be paid by a milk purveyor of liquid milk for fresh cow's milk delivered to him by a processor shall be E2.00 per litre for packaged milk or E1.95 per litre for bulk milk.

Maximum selling prices of fresh Cow's Milk.

4. The maximum selling price of fresh cow's milk by dairies, milk shops, milk Purveyors to the public shall be E2.10 per litre for cartoned milk or E1.05 for 500ml carton.

Maximum price to be paid to a milk processor of Full Cream Emasi (Cultured Milk).

5. The price to be paid by a Purveyor of Full Cream Emasi (Cultured Milk) delivered to him by a processor shall be E2.00 per litre for packaged cultured milk or bulk cultured milk.

Maximum Selling Price for Full Cream Emasi (Cultured Milk).

6. The maximum selling price of cartoned Full Cream Emasi (Cultured Milk) by dairies, milk shops and milk purveyors to the public shall be E2.00 per litre or E1.05 per 500ml carton

Revocation of Legal Notice No.4 of 1991.

7. The prices of Liquid Milk and Full Cream Emasi Emvelo (Cultured Milk) Notice of 1991 is hereby revoked.

LEGAL NOTICE NO. 36 OF 1993

THE DAIRY ACT, 1968

(Act No. 28 of 1968)

LEVY ON MILK AND DAIRY PRODUCTS REGULATIONS, 1993

(Under Section 25)

In exercise of the powers conferred by Section 25 of the Dairy Act 1968, the Minister for Agriculture and Co-operatives, after consultation with the Dairy Board, hereby makes the following regulations.

Citation.

1. These Regulations may be cited as the Levy on Milk and Dairy Products Regulations, 1993 and shall be deemed to have come into force on the 1st of June 1992.

Levies to be paid by Producers and Importers of Milk.

- All importers of milk and all producers of milk produced in Swaziland save and except such
 producers who sell all their milk to the processing plant of the Swaziland Dairy Board, shall pay the
 following levies.
 - (a) 5 cents per litre of milk produced
 - (b) 10% of the invoice value of imported milk

Levies to be paid by Manufacturers and Importers of Dairy Products.

- All manufacturers and Importers of dairy products shall pay the following levy:
 viz. 10% of the invoice value of the imported dairy product listed on Schedule.
- (a) All imports of dairy products must be supported by the necessary import permit as required by Section 18 of the Dairy Act

Repeal of Legal Notice No. 30 of 1987.

5. Legal Notice No. 30 of 1987 is hereby repealed.
