LEGISLATIVE PROCEDURE (AMENDMENT) DECREE

In exercise of the powers vested in me in terms of the King's Proclamation to the Nation of 12th April, 1973, I, MSWATI III, KING OF SWAZILAND, hereby make this Decree -

Short title.

1. This Decree may be cited as the Legislative Procedure (Amendment) Decree 1993 and shall be read as one with the Legislative Procedure Decree No. 4 of 1992 (herein after referred to as "the principal Decree")

Replacement of section 2.

2. Section 2 of the principal Decree is replaced with the following -

"This Decree shall operate pending the establishment of a new Parliament within the first ten months of 1993."

In exercise of the powers conferred on me by the above Order, I hereby proclaim that the General election of the Members of the House of Assembly shall take place in Swaziland on the following days:

Nomination day 21st August 1993;

Primary Election 18th September 1993;

Secondary Election 11th October 1993;

I hereby command and authorise Umphatsi-Lukhetfo to issue on my behalf the necessary Writ of Election in connection therewith, under section 4(1) of the above Order.
