## GENERAL NOTICE NO. 2 OF 1995

## THE RATING ACT, 1967

(Act No. 24 of 1967)

## INSPECTION OF AND OBJECTIONS TO DRAFT SUPPLEMENTARY VALUATION ROLL NOTICE, 1995.

(Under Section 24)

Notice is hereby given to all owners of immovable properties in the Nhlangano, Piggs Peak and Siteki Urban Areas that in terms of Section 24 of the Rating Act, 1967, a supplementary valuation roll has been prepared. Upon confirmation of the supplementary valuation roll, the figures in the roll will determine the rates that each property owner will pay.

In terms of Section 15 of the Rating Act, 1967 owners are notified that:

- a) the supplementary valuation roll is open for public inspection at the offices of the Council and any person may, free of charge, inspect it and take copies or extracts therefrom during normal working hours.
- b) The Town Council or the owner or occupier of any property included in the supplementary valuation roll, or their duly authorised representatives, may make an objection to any valuation, or in respect of any other error, omission or misdescription in such roll, in the case of:

  - ii) an owner or occupier of property, in respect of the property;
- Any objection to the supplementary valuation roll must be lodged with the Town Clerk on or before 3rd March, 1995;
- d) All objections must be lodged on the prescribed form and set out the grounds upon which the objection is based before the expiry of the date mentioned above, otherwise the objection cannot be heard by the valuation court.
- e) The valuation courts will sit on 20th March 1995 to consider and determine any objection duly lodged at the Court House, Nhlangano, Court House, Piggs Peak and Court House, Siteki.
