THE BUILDING ACT, 1968  
(Act No. 34 of 1968)

THE STANDARD BUILDING (AMENDMENT) REGULATIONS, 1995  
(Under Section 37)

In exercise of the powers conferred by Section 37 of the Building Act, 1968, the Minister for Housing and Urban Development hereby amends the following Regulations:

*Citation .*

1. These Regulations may be cited as the Standard Building (Amendment) Regulations, 1995, and shall be read as one with the Standard Building Regulations, 1969 (hereinafter referred to as "the Principal Regulations") and shall be deemed to have come into force on the 1st January 1995.

*Amendment of Regulations 218.*

2. Regulation 218 of the Principal Regulations is amended by replacing it with the following-  
*"Offences and penalties"*

218. Any person who

- (a) Contravenes any of these Regulations; or
- (b) fails to comply with the requirements or any notice served within the time specified thereon,

shall be guilty of an offence and liable on conviction to a fine not exceeding five hundred Emalangeni in the case of a first conviction or in the case of a second or subsequent conviction for the same offence, a fine not exceeding one thousand Emalangeni, or in default of payment of fine in either case, imprisonment for a period not exceeding eighteen months and in the case of a continuing offence to a further, fine not exceeding fifty Emalangeni for each day during which the offence is continued."
