THE AVIATION ACT, 1968

(Act No. 31 of 1968)

THE AVIATION (AMENDMENT) REGULATIONS, 1995

(Under Section 21)

In exercise of the powers conferred by Section 21 of the Aviation (Amendment) Act, 1968 the Minister for Transport and Communications hereby makes the following Regulations -

Citation.

1. These Regulations may be cited as the Aviation (Amendment) Regulations, 1995.

Amendment of Regulation 238.

- Regulation 238 is amended by inserting the following new sub-regulations after sub-regulation
 -
 - "(3) Save in an emergency or with the approval of the Director -
 - (a) no person shall convey within the airport any explosives or other dangerous devices which may be used for the commission of an offence or load such explosives or devices on an aircraft.
 - (b) no cargo, baggage, mail couriers, express parcels, stores or operator's supplies intended for carriage on an aircraft shall be moved within the airport unless they have been examined or thoroughly checked by the members of the Royal Swaziland Police Force.
 - (4) The Royal Swaziland Police shall also be responsible for the screening of all persons who board or alight from any aircraft that uses the airport."
