# THE CENTRAL BANK ORDER, 1974 (Order No. 6 of 1974)

# THE MANUFACTURE AND CHARACTERISTICS OF THE TWO EMALANGENI COINS NOTICE, 1995 (Under Section 24)

In exercise of the powers conferred by Section 24 of the Central Bank of Swaziland Order, 1974 (As Amended), the Bank issues the following notice.

#### Citation and Commencement.

1. This notice may be cited as the Manufacture and Characteristics of the Two Emalangeni Coins Notice, 1995 and shall come into force on the date of publication in the Gazette.

#### Legal Tender.

The Two Emalangeni coin issued by the Central Bank of Swaziland under Section 24 shall be legal tender as provided under Section 23 of the Central Bank Order, 1974.

Denomination, Material, Dimension, Weight & Shape.

3. The coin shall consist of Aluminium Bronze of the following materials, dimensions, weight and shape:-

DENOMINA- TION	MATERIAL	DIAMETER IN MILLIMETRES		SHAPE
Emalangeni 2	Aluminium Bronze	24 plus minus 0.05	5 plus minus 3%	Round fine serration

#### Design and Inscription of Coin.

- 4. The coin shall bear the following designs and inscriptions:-
  - (i) On the obverse side in the centre,
    - (a) there shall be inscribed the image of His Majesty King Mswati III
    - (b) above the image of His Majesty shall be the word "SWAZILAND".

- (ii) On the reverse side
  - (a) the year of manufacture shall be printed on the top.
  - (b) the middle shall be dominated by the image of an Calla Lily Czantedeschia Rehmannii and its branches spreading towards the right.
  - (c) the figure 2 in Arabic numericals shall appear towards the left side of the coin.
  - (d) Centrally printed below (b) and (c) shall be the inscription "EMALANGENI".

# ANIMAL DISEASE ACT, 1965 (Act No. 7 of 1965)

# THE STOCK DISEASE (RABIES NO. 18) REGULATION, 1995 (Under Section 3)

In exercise of the powers conferred by Section 3 of the Animal Diseases Act. 1965 the Minister for Agriculture and Cooperatives hereby makes the following Regulations:

Citation and Commencement.

1. These Regulations may be cited as the Stock Disease (Rabies No. 18) Regulations 1995 and shall be deemed to have come into force on 30th November, 1995.

Declaration of Rabies Guard Areas.

The areas specified in the First Schedule (Schedule 1) hereto are hereby declared to be Rabies Guard Areas.

Isolation and Confinement of Dogs.

3. Every owner of a dog or cat in a guard area shall isolate and confine his dog or cat so as to prevent it from escaping from such guard areas. Such confinement and isolation shall remain inforce until further notice.

Presentation of Dogs and Cats for Vaccination.

4. A person who owns a dog or cat and lives within the area specified in the first schedule to this Notice shall present his pets for inoculation at the designated vaccination centre and on the time specified in schedule 2.

Offence and Penalty.

5. An owner of a dog or cat who fails to comply with Regulation 3 shall be guilty of an offence and upon conviction, liable to a fine not exceeding E300.00 or in default of payment, to imprisonment for period not exceeding 3 months.

Destruction of Dogs and Cats in Rabies Guard Areas.

6. A Government Veterinary Officer may destroy a dog or cat in any of the Rabies guard areas if in his opinion, the dog or cat has not been confined so as to prevent it from escaping from such guard areas.

## LEGAL NOTICE NO. 186 OF 1995

# ANIMAL DISEASE ACT, 1965 (Act No. 7 of 1965)

# THE STOCK DISEASE (RABIES NO. 19) REGULATION, 1995 (Under Section 3)

In exercise of the powers conferred by Section 3 of the Animal Diseases Act. 1965 the Minister for Agriculture and Cooperatives hereby makes the following Regulations:

Citation and Commencement.

 These Regulations may be cited as the Stock Disease (Rabies No. 19) Regulations 1995 and shall be deemed to have come into force on 6th December, 1995.

Declaration of Rabies Guard Areas.

The areas specified in the First Schedule (Schedule 1) hereto are hereby declared to be Rabies Guard Areas.

Isolation and Confinement of Dogs.

3. Every owner of a dog or cat in a guard area shall isolate and confine his dog or cat so as to prevent it from escaping from such guard areas. Such confinement and isolation shall remain inforce until further notice.

Presentation of Dogs and Cats for Vaccination.

4. A person who owns a dog or cat and lives within the area specified in the first schedule to this Notice shall present his pets for inoculation at the designated vaccination centre and on the time specified in schedule 2.

Offence and Penalty.

5. An owner of a dog or cat who fails to comply with Regulation 3 shall be guilty of an offence and upon conviction, liable to a fine not exceeding E300.00 or in default of payment, to imprisonment for period not exceeding 3 months.

Destruction of Dogs and Cats in Rabies Guard Areas.

6. A Government Veterinary Officer may destroy a dog or cat in any of the Rabies guard areas if in his opinion, the dog or cat has not been confined so as to prevent it from escaping from such guard areas.
