LEGAL NOTICE NO. 16 OF 1996

THE FINANCE AND AUDIT ACT, 1967 (Act No. 18 of 1967)

THE ADMINISTRATION OF THE SMALLL AND MEDIUM SCALE BUSINESS DEVELOPMENT FUND (THE ENTERPRISE FUND) REGULATIONS, 1996 (Under Section 12)

In exercise of the powers conferred by Section 12 of The Finance and Audit Act, 1967 the Minister for Finance makes the following Regulations.

Citation and Commencement

1. These Regulations may be cited as the Administration of the Small and Medium Scale Business Development Fund Regulations, 1996 and shall come into operation on the date of publication in the Gazette.

Application.

2. These Regulations shall apply to the Small and Medium Scale Business Development Fund (The Enterprise Fund) established under Legal Notice No. 150 of 1995.

Purpose of the Fund.

- 3. The purpose of the Fund shall be to -
 - (a) receive eight million (E8,000,000.00) Emalangeni from Tibiyo Taka Ngwane;
 - (b) receive thirty-six million (E36,000,000.00) Emalangeni of bilateral assistance from friendly and supportive donor;
 - (c) receive assistance and donations from bilateral assistance, public and private persons;
 - (d) receive interest income generated from the operations of the Fund;
 - (e) receive any other income or funds for its purposes, including rentals, loan recoveries and Government contributions or any other contributions;
 - (f) finance, support and promote the development of Swazi owned small and medium scale business enterprises through the medium of intermediary organizations or agents which shall be selected or approved by the Fund's Management Committee appointed under Regulations 7;
 - (g) support the provision of business advisory and information services, training facilities, monitoring, technology transfers and the development of new products and services to small and medium scale business by third parties by grant or loan finance as may be determined by the Enterprise Fund Management Committee; and

(h) support the expansion of loan financing to small and medium scale business through carefully selected intermediary organizations or agents in the form of providing loans.

Mode of support.

- 4. (1) The Fund shall, through the Enterprise Fund Management Committee, finance, support and promote the small and medium scale businesses by the provision of loans or grants in terms of sub-regulation 2 of Regulation 10 in the case of loans.
- (2) The agents or intermediary organizations shall be responsible for the disbursement of the loans and their recovery together with interest.
- (3) The agents or the intermediary organizations shall only grant loans to Swazi owned small and medium scale businesses.

Interest rates.

- 5. (1) The Agents of the Fund or the intermediary organizations approved by the Fund shall charge interest at the prevailing market rates on all loans from the Fund and pay same, less any agreed administrative and risk margins, to the account of the fund.
 - (2) The interest received shall accrue to the Fund.

Account of the Fund.

- 6. (1) The Minister for Finance shall cause to be opened a bank account for and in the name of the Fund with the Central Bank of Swaziland.
- (2) The Enterprise Fund Management Committee shall, in collaboration with the Minister for Finance, pay from the account all operating costs properly incurred in the administration of the Fund.

Administration of the Fund.

- (1) The Fund shall be administered by a management committee to be known as the Enterprise Fund Management Committee.
- (2) The Enterprise Fund Management Committee shall be appointed by the Minister for Finance and shall consist of nine (9) members, of whom one shall be a Chairman, on terms and conditions as the Minister deems fit.
- (3) The Minister shall, in making the appointments, ensure that an overall balance of technical, professional, commercial and financial skills is maintained on the Enterprise Fund Management Committee.
- (4) The Minister shall, in the interest of continuity appoint the members in a manner that they do not all at once vacate office.

Term and Vacation of Office.

8. (1) The Minister for Finance shall appoint the members referred to in Regulation 7 for a term of three (3) years and may terminate a member's term of office at any time he deems it necessary.

- (2) Subject to sub regulation (3), the Minister may renew a member's term of office or reappoint to office a member whose term he terminated, if the Minister reasonably believes that person's services are essential to the Fund.
- (3) Notwithstanding any provision of this regulation, the Minister shall not appoint a person to serve as a member for more than two consecutive terms of office.

Functions of the Committee.

- 9. The Committee shall -
 - (a) be responsible for the administration of the Fund;
 - (b) select or approve the selection of agents of the fund or intermediary organizations for the disbursement, recovery of the loans and any other incidental matters.
 - (c) ensure that the operations of the Fund are subject to periodic reporting;
 - (d) ensure that annual and independent audits are carried out and that the audited accounts and the reports of the auditors on the Fund's operations are submitted to the Minister for Finance for his action.
 - (e) make its own rules of procedure, including the formation of a quorum and the calling of its meetings.

Agents and intermediaries.

- 10. (1) The Enterprise Fund Management Committee shall select or approve of an agent or intermediary organization because of its proven successful record of credit administration.
- (2) An Agent or intermediary organization shall take into account, before granting a loan to a small or medium business, its capability to repay the loan.
