## LEGAL NOTICE NO. 9 OF 1996

### THE FINANCE AND AUDIT ACT, 1967 (Act No. 18 of 1967)

#### THE ESTABLISHMENT AND ADMINISTRATION OF KOMATI AND USUTHU PILOT PROJECT LOAN REVOLVING FUND REGULATIONS, 1996 (Under Section 12)

In exercise of the powers conferred by section 12 of the Finance and Audit Act, 1967 the Minister for Finance makes the following Regulations.

#### *Citation and Commencement.*

1. These Regulations may be cited as the Establishment and Administration of Komati and Usuthu Pilot Project Loan Revolving Fund, 1996 and shall come in operation on the date of publication in the Gazette.

#### *Interpretation.*

2. In the Regulations, unless the context otherwise requires -

"administrator" means either Mhlume Sugar Company or Ubombo Ranches Limited as the case maybe;

"Committee" means the Komati and Usuthu Pilot Project Loan Revolving Fund Management Committee established under Regulation 11;

"concessionary" rate means a lending rate more favourable to the association of farmers than a commercial lending rate associated with financial institutions; and;

"Fund" means the Komati and Usuthu Pilot Project Loan Revolving Fund established under Regulation 3;

#### *Establishment of the Fund.*

3. There is established a Fund under section 12 of the Finance and Audit Act, 1967 to be known as the Komati and Usuthu Pilot Project Loan Revolving Fund and shall be operational for a period to be determined by the Minister for Finance but not less than eighty-four (84) months from date of Commencement of these Regulations.

#### *Purpose of the Fund.*

4. The purpose of the Fund shall be to -

- (a) receive the capital sum of E3,343,000.00 (three million, three hundred and forty three thousand Emalangeni) from the Government and may receive any additional funds from whatever source for its purposes;

- (b) receive interest funds generated from lending to approved association of farmers envisaged by these Regulations;
- (c) finance capital requirements for the Nyakatfo (Komati) Pilot Sugarcane Project and the Lobovu (Usuthu) Pilot Irrigation Project through loans payable not in cash, except for the payment of labour or wages, but in the form of purchase vouchers or authorities issued by an administrator of the Fund to an approved association of farmers; and
- (d) finance the Capital requirements mentioned in paragraph
- (e) through Mhlume Sugar Company and Ubombo Ranches Ltd.

*Application.*

5. (1) The Fund shall apply to small-holder sugar cane producers participating in associations of farmers in the Nyakatfo Pilot Sugarcane Project (Nyakatfo Scheme) and Lobovu Pilot Irrigation Project (Lobovu Scheme).

(2) The loans from the Fund shall be disbursed to associations of farmers through Mhlume Sugar Company and Ubombo Ranches Ltd in accordance with paragraph (c) of Regulation 4.

*Administration of the Fund.*

6. The Fund shall consist of two Administrators, that is, Mhlume Sugar Company shall be responsible for the Fund's administration in respect of the Nyakatfo (Komati) Pilot Sugarcane Project and Ubombo Ranches Limited in respect of the Lobovu (Usuthu) Pilot Irrigation Project.

*Function of the Administrators.*

7. An Administrator shall -

- (a) in conjunction with the Ministry for Agriculture identify any association of farmers eligible or qualifying to be participant of the Fund's projects, that is, borrowers to the Fund;
- (b) after compliance with paragraph (a), submit the name and all relevant particulars or information of that association of farmers to the Committee for approval and the Committee may give or withhold its approval;
- (c) after approval by the Committee, disburse the loan (funds) to an approved association of farmers in accordance with the seasonal or loan disbursement procedure applicable or agreed upon and in conformity with paragraph (c) of Regulation 4;
- (d) not grant more than one loan package to an association of farmers, that is, during the life of the Fund or that of the Association;
- (e) shall deduct, seasonally through the "Stop Order" system in that Administrators field of operation, monies due to the Fund and transmit same, less administrative fees as agreed upon, to the account of the Fund;



- (f) ensure, unless the Minister for Finance grants an extended period of repayment due to or necessitated by a vis major, that the loan and interest on the loan is fully paid by an association of farmers to the Fund within a period of eighty-four (84) months from the date of approval or disbursement of the loan; and
- (g) in conjunction with the Minister for Agriculture and Co-operatives, exercise proper loan management.

*Tenure of Loans.*

- 8. An approved association of farmers shall be entitled to one loan package extending over a period not exceeding eighty-four (84) months and that association shall be liable to repay the capital loan and interest within the eighty-four (84) months.

*Rate of Interest.*

- 9. (1) A concessionary rate of interest of 17% shall be applicable and charged annually on every loan approved.
- (2) The Committee together with the Minister for Finance shall review annually the concessionary rate and whilst doing so, shall keep the interest rate concessionary.
- (3) The interest earned shall accrue to the Fund.

*Liability of Members of an association.*

- 10. (1) Every member of an association of farmers granted a loan by the Fund shall, in addition to that society, be liable personally for the full amount owing to the fund whether is still a member or not.
- (2) The Fund shall have a lien over the crops and any other property of an association of farmers indebted to the Fund until all monies due to the Fund are paid in full.
- (3) Where the Fund for any reason whatsoever can not exercise any right accruing to it by reason of its establishment or operation, that right shall be exercised by the Government.

*Establishment of the Komati and Usuthu Pilot Project Loan Revolving Fund Management Committee.*

- 11. There is established a Management Committee to be known as the Komati and Usuthu Pilot Project Loan Revolving Fund Management Committee (the Committee) and shall consist of -
  - (a) a Chairman who shall be the Principal Secretary or his alternate for the Ministry of Agriculture and Cooperatives;
  - (b) two Administrators, one shall be the Financial Manager of Mhlume Sugar Company or his alternate and the other shall be the Financial Manager of Ubombo Ranches Ltd or his alternate;

(c) two members who are Agricultural Managers, one from Mhlume Sugar Company or his alternate and the other from Ubombo Ranches Ltd or his alternate, and

(d) two other members who shall be the Principal Secretary for the Ministry of Economic Planning and Development or his alternate and the Principal Secretary for the Ministry of Finance or his alternate.

*Quorum and procedure of Meetings.*

13. The Committee shall make rules for the regulation of its business including procedure relating to its meetings, voting and the formation of a quorum.

*Function of the Committee.*

14. (1) The Committee shall, in pursuance of paragraph (b) of Regulation 7, approve or withhold its approval to proposed borrowers of the Fund.

(2) The Committee shall monitor the application of the monies of the Fund, progress of the Fund or scheme and where necessary make the necessary adjustments for the success of the scheme of the Fund.

(3) The Committee shall in conjunction with the Administrators ensure that the loans together with interest are paid in full within eighty-four (84) months.

(4) The Committee shall specially meet twice annually, that is, in March and December to review each loan granted to an association of farmers to ensure that the projects are properly managed to generate projected revenue to service the loans.

(5) The Committee shall submit quarterly reports to the Ministers of Finance and Agriculture and Co-operatives showing, among other things, the financial status and loan repayments performance of the borrowers of the Fund and any recommendations to be considered by Government.
