## LEGAL NOTICE NO. 89 OF 1996

ANIMAL DISEASE ACT, 1965  
(Act No. 7 of 1965)THE STOCK DISEASE REGULATIONS, 1996  
(Under Regulation 11)

In exercise of the powers conferred on him by regulation 11 of the animal Disease Act, 1965 the Director of Veterinary Services issue the following notice.

*Citation and commencement.*

1. This Notice may be cited as the Dipping of Stock Notice, 1996 and shall come into force on the 14th day of June, 1996.

*Compulsory Dipping of Stock.*

2. (i) Subject to sub-rule (2) all owners of cattle in Swaziland shall dip cattle once every fourteen (14) days.
- (ii) Not with standing sub-rule (1) owner of cattle in the schedule here to shall dip their cattle once every twenty-eight (28) days.

*Dipping Hours.*

3. Subject to any order to the contrary issued by an officer authorized under regulation 11, of Stock Diseases Regulation 7/1965 (1) dipping hours under regulation (2) of this notice shall be between 5.00 a.m. to 12 noon.

*Revocation of Legal Notice No. 155 of 1995*

4. The dipping of stock Legal Notice No. 155 of 1995 is hereby revoked.
