THE STOCK DISEASES REGULATIONS, 1933  
(Under Section 3 of Act No. 7 of 1965)THE INOCULATION OF DOGS AGAINST RABIES NOTICE, 1996  
Under regulation 16)

In exercise of the powers conferred by regulation 16 of the Stock Diseases Regulations, 1933 the Director of Veterinary Services issues the following notice.

*Citation and Commencement.*

1. This notice may be cited as the Inoculation of Dogs Against Rabies Notice, 1996 and shall be deemed to have come into operation on the 1st September, 1996.

*Compulsory Vaccination of dogs against Rabies.*

2. A person who owns, or has control or custody of a dog within an area specified in the Schedule to this Notice, shall present that dog for vaccination, with a vaccine approved by the Director of Veterinary Services, against rabies at the date and time and at the Inoculation Centre for that area as is specified in the Schedule.

*Offences and penalties.*

3. A person who refuses or fails to comply with the requirements of regulation 2, or who contravenes the provisions of regulation 2, commits an offence and is liable, on conviction, to a fine of fifty Emalangeni (E50.00), failure of which, to imprisonment for period not exceeding three (3) months.
