AMENDMENT OF SCHEDULE NOTICE, 1997

Citation and Commencement.

1. This Notice may be cited as the Stamp Duties (Amendment of Schedule) Notice, 1997 and shall come into force on the date of publication in the Gazette.

Amendment of Schedule.

2. The Schedule to the Stamp Duties Act, 1970 is amended under item No. 17 by adding after the proviso to paragraph (2) the following -

"Further exemption from the duty under paragraph (1) and (2) - Where the original issue of a marketable security is listed on the Swaziland Stock Market and the subsequent registration of transfer of such marketable security is conducted or done through the Swaziland Stock Market by a stock-broking company licensed to operate in Swaziland in terms of the Financial Institutions Order, No. 23 of 1975."
