In exercise of the powers conferred by regulation 16 of the Stock Diseases Regulations, 1933 the Director of Veterinary Services issues the following notice.

2. 3. A person who refuses or fails to comply with the requirements of regulation 2, or who contravenes the provisions of regulation 2, commits an offence and is liable, on conviction, to a fine of fifty Emalangeni (E50.00), failure of which, to imprisonment for period not exceeding three (3) months.
