#### LEGAL NOTICE NO. 172 OF 1997

#### URBAN GOVERNMENT ACT, 1969 (Act No. 8 of 1969)

#### APPOINTMENT OF LOCAL AUTHORITY INSPECTORS FOR MANZINI CITY COUNCIL NOTICE, 1997 (Under section 105)

In exercise of the powers conferred by section 105 of the Urban Government Act, 1969 the Minister for Housing and Urban Development issues the following notice.

Citation and Commencement.

1. This notice may be cited as the Appointment of Local Authority Inspectors for Manzini City Council Notice, 1997 and shall come into force on the 17th of November, 1997.

Appointment of Inspectors.

2. The Minister for Housing and Urban Development appoints -

- (a) Mr Isaac Shabangu; and
- (b) Mr Nkonzo Hlatshwayo,

to be local authority inspectors to the Manzini City Council with effect from 17th November, 1997.

Powers and Duties of the Inspectors.

3. (1) The Inspectors shall inspect the observance and performance of the Manzini City Council of the duties and powers imposed or conferred upon it by the provisions of the Urban Government Act, 1969 or any other law.

(2) The Inspectors shall exercise the powers and duties imposed by subsection (2) of section 105 of the Urban Government Act, 1969.

Duration and Submission of Report.

4. The Inspectors shall submit a final report within a period not exceeding thirty (30) days from the date of coming into force of this notice.

Allowances.

5. The Inspectors shall be entitled to such allowances as are payable to Government Officers as per Government scales or as the Minister may determine.

#### LEGAL NOTICE NO. 173 OF 1997

#### COMMISSION OF ENQUIRY ACT, 1963 (Act No. 35 of 1963)

#### THE COMMISSION OF ENQUIRY TO REVIEW REPRESENTATIONS ON THE INTENTION TO ALTER THE URBAN BOUNDARIES OF NHLANGANO (Under Section 3)

In exercise of powers conferred by Section 3 of the Commission of Enquiry Act, 1963, I hereby issue the following notice.

Citation and Commencement.

1. This notice may be cited as the Commission Of Enquiry To Review Representations On The Intention To Alter The Urban Boundaries Of Nhlangano, Notice, 1997 and shall come into operation on the date of publication.

Establishment and Composition of Commission.

2. (1) There is established a commission of enquiry to be called the Commission Of Enquiry To Review Representations On The Intention To Alter The Urban Boundaries Of Nhlangano.

(2) The Commission shall consist of following members -

Mr. Mcabango Dlamini	-	Chairman
Mr. Reginald Dladla	-	Member
Mr. Peterson Dlamini	-	Member
Mr. Sicelo Tembe	-	Secretary

Functions of the Commission.

- 3. The Commission shall -
  - (a) hear and consider representations received in response to the notification published under section 4 of the Urban Government Act, 1969, as contained in General Notice No. 58 of 1997.
  - (b) advise the Minister for Housing and Urban Development whether or not the intended notice to alter the boundaries of Nhlangano, referred to in such notification, should be published or proceeded upon;
  - (c) advise the Minister on any matter arising from the submissions so made as the result of the notification; and
  - (d) make recommendation to the Minister on appropriate action the Minister may take as a consequence of the notification or submissions so made.

#### Procedure of commission.

4. (1) The Commission shall receive oral and documentary submissions from members of the public who submitted their objections in writing as provided for in terms of General Notice No. 58 of 1997.

(2) Notwithstanding subsection (1), where a just reason is given, the Commission may receive submissions from persons other than those who lodged their objections provided such person are present and before the Commission.

(3) The Commission shall permit legal representation provided the person objecting is also present and before the Commission, and provided further that the person objecting qualifies in terms of this section or is so permitted by the Commission.

Inquiry to be in public.

5. Unless the Minister otherwise directs the enquiry shall be held in public.

Quorum.

6. The quorum of the Commission shall be three members.

Date of commencement of commission.

7. The enquiry shall commence its work on the 17th November, 1997.

Venue and address of the Commission.

8. (1) The enquiry shall be held at Nhlangano civil office, Nhlangano, or at such other place and at such times as the Chairman may determine.

(2) The postal address of the Commission shall be P.O. Box 1832, MBABANE.

Submission of report.

9. The Commission shall present its final report to the Minister not later than the 19th December, 1997 or such later date as the Minister may, in writing permit.

Allowances.

10. The Commissioners shall be entitled to such allowances as are payable to Government officer as per Government scales or as the Minister may determine.
