## INDUSTRIAL RELATIONS ACT, 1996 (Act No. 1 of 1996)

## APPOINTMENT OF CO-OPTED MEMBERS OF THE LABOUR ADVISORY BOARD (Under Section 23)

It is notified for general information that the following persons are co-opted, in terms of section 23 (2) of the Industrial Relations, 1996, as members of the Labour Advisory Board to be known as the Industrial Relations Drafting Committee with effect from 8th of July, 1998 to the 31st August, 1998 to carry out the functions specified under section 2 of this Notice.

#### Functions of the Committee.

2. The Committee shall -

- (a) review and incorporate, if necessary, the subsequent submissions received after the 9th of March 1998 presented by -
  - (i) the Federation of Swaziland Employers;
  - (ii) the Acting Chief Justice of the High Court;
  - (iii) the President of the Industrial Court; and
  - (iv) the Minister for Enterprise and Employment.
- (b) assist the Minister for Enterprise and Employment as well as the Labour Advisory Board in presenting the Industrial Relations Bill, 1998 before the Parliamentary Portfolios Committee; and
- (c) carry out any other work relating to the Industrial Relations Bill, 1998 as the Minister of Enterprise and Employment or the Labour Advisory Board may assign to the Committee;

## Draft Bill to be presented to the Labour Advisory Board.

3. The Committee shall deliver the draft Bill or such amended draft Bill of the proposed Industrial Relations legislation not later than the 15th of July, 1998 or such later time as the Minister may permit.

## Allowances.

4. The Committee shall be paid sitting and travelling allowances equal to those payable to persons in statutory bodies.

## Extension of time.

5. The Labour Advisory Board in consultation with the Minister may extend the time specified under section 3 of the Notice by notice published in the Gazette.
