Design and Inscription of the Note.

4. (1) The obverse side will feature the following elements -

- (a) to the left of the centre, the printed image of His Majesty King Mswati III;
- (b) to the right of the centre, in an unprinted white area, a watermark representing a Swazi shield complete with two spears and a staff;
- (c) at the top and centrally printed, the words "THE CENTRAL BANK OF SWAZILAND" and below this, the words "THIS NOTE IS LEGAL TENDER FOR EMAKHULU LAMABILI EMALANGENI", all in capital Roman letters;
- (d) in the centre of the note, the image of the Parliament Buildings;
- (e) centrally, in the bottom border, and partly obscuring the Parliament Buildings, the National Coat of Arms. The National Coat of Arms consists of an image of the Swazi shield with two spears and a staff, an elephant with its trunk raised on the right of the

shield, and a lion with its left paw raised on the left of the shield. The scroll forming the lower border of the Coat of Arms, bears the inscription, "SIYINQABA" in Roman letters;

- (f) on the right hand side of the note, a ceremonial arm-bank "Ingece" overlayed by a shiny lead strip on which is printed in extra-small text "E200";
 - (g) to the left of the printed image of His Majesty, the image of a Swazi shield with two spears and a staff with feathers, this image being printed in perfect register with a similar feature on the reverse of the note;
 - (h) overlying the image of the Parliament Buildings, the printed designations "MINISTER FOR FINANCE" (to the left) and "GOVERNOR" together with facsimile signatures of the incumbents respectively;
 - (i) at the top left, top right and lower-right corners, the printed value "E200" (Two Hundred) in Arabic numerals;
 - (j) the serial numbers of the note consist of two Roman capital letters and seven Arabic numerals:-
 - (i) the left-hand serial number is printed horizontally in black, below the portrait of His Majesty; and
 - (ii) the right-hand serial number is printed vertically in black to the left of the watermark area, which itself is on the right-hand side of the note.
 - (k) to the left of centre, a security thread incorporated in the paper of the note, comprising the repeated extra-small text "THE CENTRAL BANK OF SWAZILAND", which becomes visible when viewing the note against a source of light;
 - (l) on the front left three dots of the feature for the blind; and
 - (m) a border of intricate geometrical designs.
- (2) The reverse of the note, will feature the following elements -
- (a) at the top, the words "God Is Our Source";
 - (b) below the words, "God Is Our Source", the words "CENTRAL BANK OF" in lower case Roman letters followed by the word, "SWAZILAND" in upper case Roman letters;
 - (c) at the bottom, the words, "TWO HUNDRED EMALANGENI" in upper case Roman letters;
 - (d) at the top left and right corners, and to the left of centre in the lower border, the Arabic numerals "200" (Two Hundred).
 - (e) the main feature at the centre of the note shall depict a Swazi Village arrangement of huts with images of people in front;
 - (f) on the top left of the Swazi Village image, the official insignia of the Central Bank of Swaziland.
 - (g) on the right of the note, an image of a Swazi shield with two spears and a staff, in perfect register with similar image on the front;
 - (h) a latent image;

- (i) a border of intricate geometrical designs to those on the obverse front; and
- (j) on the sides, the words "30th Independence Anniversary".
