# THE APPOINTMENT OF THE CELLULAR EVALUATIONS COMMITTEE NOTICE, 1998 (Under section 3)

In an exercise of the powers conferred by section 3 of the Commissions of Enquiry Act of 1963 the Minister for Tourism, Environment and Communications issues the following notice:-

#### Citation and commencement.

1. This notice may be cited as the Appointment of the Cellular Evaluations Committee Notice 1998 and shall be deemed to have come into force on the 2nd January 1998.

### Establishment and Composition of Committee.

2. (1) There is hereby established a committee to be known as the Cellular Evaluations Committee hereafter in this notice referred to as "the committee" and shall be composed of the following persons as its members:-

(a) R. M. Dhladhla	Chairman
(b) P. B. Vilakati	Member
(c) Mr S. M. Mkhonta	Member
(d) Mr M. S. Magongo	Tourism and Communications
(e) Mr Victor Nxumalo	Finance
(f) Mr Steven Motsa	Enterprise and Employment
(g) Ms Pholiswa Xuba	Economic Planning
(h) Ms Sibongile Nsibandze	Attorney General

(2) The Minister may remove, for the better carrying out of the functions of the committee any member of the committee from office at anytime without giving any reasons to any person or member.

#### Functions of the committee.

- 3. The committee with the assistance of the Technical Advisors which are Pricewaterhouse (PW), shall do the following duties and functions, that is;
  - (a) issue requests for proposals (RFPs) for the cellular project;
  - (b) to receive from bidders tender documents for the above project and evaluate them for the purpose of selecting a preferred joint venture partner for SPTC;
  - (c) to recommend to the Minister of Tourism, Environment and Communications who shall take the recommendation to Cabinet for final approval and;
  - (d) the committee shall finish its work and present a final report to the minister not later than 1st November, 1998

#### Allowances and Reimbursements.

4. The members of the committee shall be entitled to sitting allowances and where applicable, reimbursement for travelling expenses.

### Extension of Time.

5. The Minister with the Cabinet Approval may extend the time specified under section 3 of the Notice by a notice published in the Gazette.
