(4) No workmen's compensation claims shall be paid in arrears as a result of the review of the maximum and minimum rates.

## THE WORKMEN'S COMPENSATION ACT, 1983 (Act No. 7 of 1983)

## THE WORKMEN'S COMPENSATION (MEDICAL EXPENSES) REGULATIONS, 1999 (Under section 45)

In exercise of the powers conferred by section 45 of the Workmen's Compensation Act, 1983, the Minister for Enterprise and Employment, after consultation with the Minister for Health and Social Welfare, hereby makes the following Regulations -

#### Citation and commencement.

1. These Regulations may be cited as the Workmen's Compensation (Medical Expenses) Regulations, 1999 and shall come into force on the 1st April, 1999.

Medical expenses payable by employer.

2. The limit of medical expenses to be paid by an employer on behalf of a workman is increased . by 15% as shown in the Schedule to this Notice.

3. The amounts listed in the Schedule for the years 1992 to 1998 are for the purpose of illustrating the method of deriving at the new rates of medical expenses.

4. No medical expenses claim shall be paid in arrears as a result of this review of maximum medical expenses.
