LEVY ON MILK AND DAIRY PRODUCTS REGULATIONS, 2000
(Under Section 25)

In exercise of the powers conferred by section 25 of the Dairy Act, 1968, the Minister for Agriculture and Co-operatives, after consultation with the Swaziland Dairy Board, hereby makes the following Regulations -

Citation.

1. These Regulations may be cited as the Levy on Milk and Dairy Products Regulations, 2000 and shall be deemed to have come into force on 1st December 1999.

Levies to be paid by importers of milk and dairy products.

2. All importers of milk and dairy products shall pay a levy as per Schedule A.

Compliance under section 18 of the Dairy Act.

3. No person shall import any dairy product without first complying with the provisions of the Dairy Act, 1968 and particularly section 18 of the Dairy Act, 1968.

Repeal of Legal Notice No. 101 of 1999.

4. Legal Notice No. 101 of 1999 is hereby repealed.
