THE NATIONAL AGRICULTURAL MARKETING BOARD ACT, 1985
(Act No. 13 of 1985)

THE IMPORT AND EXPORT OF SCHEDULE PRODUCTS
(AMENDMENT) NOTICE, 2000
(Under Section 6)

In exercise of the powers conferred by Section 6 of the National Agricultural Marketing Board Act, 1985 the National Agricultural Marketing Board hereby issues the following Notice:

Citation and Commencement

1. This Notice may be cited as the Import and Export of Schedule Products (Amendment) Notice, 2000 and shall come into force on the 21st August 2000.

Amendment of Legal Notice No. 109 of 1986

2. Paragraph 6 of the Import and Export of Scheduled Products Notice 1986 together with all subsequent amendments of it published by Legal Notices, should be replaced by the following:

The Board shall impose a levy on the value of imported scheduled products as follows:

- (a) Maize excluding seed maize, yellow maize and popcorn - between 3% and 7.5%
- (b) Maize products excluding processed poultry and animal feed - between 5% and 10.5%
- (c) Rice - 3.5%

| (d) Fresh fruits excluding apples, pears, peaches, grapes and banana. | - between 6.75% and 7.5% |
| (e) Apples, pears, peaches and grapes | - between 3% and 4.5% |
| (f) Banana | - between 6.75% and 25% |
| (g) Fresh vegetables excluding cabbages, tomatoes, potatoes and seed potatoes. | - between 6.75% and 10% |
| (h) Cabbages, tomatoes and potatoes excluding seed potatoes. | - between 6.75% and 20% |
| (i) Poultry and poultry products including live broiler birds, day old chicks and hatching eggs. | - between 5% and 15% |
| (j) Wheat | - between 3% and 5% |
| (k) Wheaten products | - between 11.5% and 18.5% |

Notification of rates

3. In the case of subsections a,b,d,f,g,h,i,j, and k the actual rate of levy to be applied at any particular date will be made known publicly in advance by the Board.
