The object of this Bill is to repeal and replace the Nutrition Council Act, 1945 and to provide for matters incidental thereto.

ENACTED by the King and the Parliament of Swaziland.

Short title and commencement

1. This Act may be cited as the National Nutrition Council Act, 2000 and shall come into force on such date as the Minister may by Notice in the Gazette, determine.

Interpretation

- 2. In this Act, unless the context otherwise requires -
 - "Council" means the National Nutrition Council established in terms of Section 3;
 - "Chairperson" means Chairperson of the Council;
 - "Minister" means the Minister responsible for Nutrition;
 - "Secretariat" means the Secretariat referred to in Section 10; and
 - "Secretary" means the Secretary of the Council.

Establishment and composition of the Nutrition Council

- 3. Subject to sub-section (2), there is hereby Established a Council to be known as the National Nutrition Council which shall consist of-
 - (a) the Director of Agriculture;
 - (b) the Director of Health Services;
 - (c) the Director of Education;
 - (d) Head of Nutrition, Ministry of Health and Social Welfare;
 - (e) Head of Public Health Unit, Ministry of Health and Social Welfare;
 - (f) Head of Home Economics, Ministry of Agriculture and Co-operatives;
 - (g) a representative of the Ministry of Economic Planning and Development;
 - (h) the Chief Commercial Officer or his representative, Ministry of Enterprise and Employment;
 - (i) a representative from Home Economics Department, University of Swaziland;
 - (j) a representative of the Nurses Training Institutions;
 - (k) four representatives of Non Governmental Organisations;
 - (1) a representative of the World Health Organisation; and
 - (m) a representative of UNICEF.
- (2) The Minister, may on the advice of the Council, appoint into the Council such persons having special skill on matters relating to nutrition on such terms and conditions including the duration of the appointment as the Minister may determine.

Functions of the Council

- 4. (1) The function of the Council is to investigate, research and report to the Minister on all matters relating directly or indirectly to the prevention of malnutrition in and the improvement of the diet of the inhabitants of Swaziland which in the opinion of the Council or the Minister should be investigated.
 - (2) In carrying out its function under this Act, the Council shall -
 - (a) co-ordinate all nutrition activities in Swaziland in governmental, non governmental and private institutions;
 - (b) identify and advocate for the development and adoption of necessary policies to support nutrition programmes;
 - (c) encourage and sustain commitment of all concerned to ensure successful implementation of nutrition programmes;
 - (d) advocate for government and donor support for nutrition or nutrition related programmes;
 - (e) collate information and research findings and develop a continuous programme for their dissemination to relevant agencies;
 - (f) commission research into relevant nutrition issues;
 - (g) set up a directory on available manpower in the country relating to nutrition;
 - (h) liaise with other international nutrition council organisations;
 - (i) monitor national policies to ensure that they do not have a negative impact on nutrition;
 - review the nutrition policy at regular intervals and make necessary recommendations to the Minister; and
 - (k) perform such other duties as the Minister may assign to the Council for the better carrying out of this Act.

Chairperson and Vice Chairperson of the Council

- 5. (1) The Director of Agriculture shall be the Chairperson and the Director of Health Services shall be the Vice chairperson of the Council.
- (2) If the office of Chairperson is vacant or the Chairperson is absent from any meeting or is unable for any other reason to perform the functions of his office, the Vice-chairperson shall act as the Chairperson.
- (3) If both the Chairperson and the Vice-chairperson are absent from any meeting or are unable for any other reason to perform the functions of their office, the members present shall elect one member to act as Chairperson.

Meetings of the Council

6. (1) Meetings of the Council shall be held at least three times a year at such times and places as the Chairperson, in consultation with the Secretary, may determine.

- (2) All decisions of the Council shall be by a majority of the members present and where there is an equality of votes, the Chairperson shall have a casting vote in addition to his deliberative vote.
- (3) The quorum for any meeting of the Council shall be two thirds (2/3) of the members of the Council.

Executive Committee of the Council

- 7. (1) There shall be an Executive Committee of the Council consisting of the Chairperson, the Vice Chairperson, the Head of the Secretariat and such number of members as the Council may determine.
- (2) The Executive Committee shall hold such special meetings for purposes handling matters of emergencies and matters relating to the day today activities of the Council as the Chairperson may determine.
- (3) The Chairperson of the Council shall chair all meetings of the Executive Committee and all major decisions of the Executive Committee shall be approved by a meeting of the whole Council.

Establishment of Sub-committee

- 8. (1) The Council may from time to time, establish different sub-committees to deal with matters assigned by the Council to these sub-committees.
- (2) The Council shall set out the composition, terms of reference and the period within which the sub-committee is to complete its task.
 - (3) A Sub-committee shall determine its own rules of precedure.

The Secretariat

- 9. (1) There shall be a Secretariat of the Council composed of-
 - (a) a nutritionist, who shall be the Head of the Secretariat;
 - (b) a Research Officer;
 - (c) Administrative Secretary;
 - (d) an Information Officer;
 - (e) a driver,
 - (f) a cleaner
 - (g) Security Guard

all of whom shall be seconded from the civil service to the Council by the Minister in consultation with the Civil Service Board.

- (2) The Council may from time to time and after consultation with the Head of Secretariat, request the Minister to further designate such other officers to the Secretariat as the need arises.
- (3) The Head of the Secretariat shall be an ex-officio member of the Council and shall also be the Secretary of the Council.

Duties of the Secretariat

10. The Secretariat shall be responsible for all administrative matters relating to the Council including co-ordinating all activities of the Council.

Powers of enquiry

- 11. (1) The Council may summon any person who in its opinion may be able to give material information concerning the subject of any investigation which is being carried out by it, to appear before it at a time and place specified in the summons.
- (2) A summons issued in exercise of the powers conferred by subsection (1) shall be signed by the Chairperson of the Council and shall be served in the same manner as it would be served if it were a subpoena issued by a magistrate's court.
- (3) Any person who having been duly summoned under subsection (1), fails without sufficient cause to attend at the time and place specified in the summons, or to remain in attendance until excused by the Council from further attendance, to answer put to him, shall be guilty of an offence and liable on conviction to a fine not exceeding one hundred Emalangeni or to imprisonment not exceeding six months.
 - (4) For purposes of this section "Council" includes any Sub-committee constituted under section 8.

Appointment of Auditor

12. The Council shall appoint an Auditor who shall audit all books and accounts of the Council for each financial year.

Annual Report

13. The Council shall not, later six (6) months after the end of the financial year, submit an Annual Report to the Minister on its activities.

Regulations

14. The Minister may make Regulations for the better carrying out of the purposes of this Act.

Repeal of the Nutrition Council Act, 1945

15. The Nutrition Council Act, 1945 is hereby repealed.

Savings

16. Not withstanding section 15, any person appointed under the repealed Act shall continue in office until the expiration of the period of appointment.
